

Mental Health (Care and Treatment) (Scotland) Act 2003

PART 1

INTRODUCTORY

1 Principles for discharging certain functions

- (1) Subsections (2) to (4) below apply whenever a person who does not fall within subsection (7) below is discharging a function by virtue of this Act in relation to a patient who has attained the age of 18 years.
- (2) In discharging the function the person shall, subject to subsection (9) below, have regard to the matters mentioned in subsection (3) below in so far as they are relevant to the function being discharged.
- (3) The matters referred to in subsection (2) above are—
 - (a) the present and past wishes and feelings of the patient which are relevant to the discharge of the function;
 - (b) the views of—
 - (i) the patient's named person;
 - (ii) any carer of the patient;
 - (iii) any guardian of the patient; and
 - (iv) any welfare attorney of the patient,

which are relevant to the discharge of the function;

- (c) the importance of the patient participating as fully as possible in the discharge of the function;
- (d) the importance of providing such information and support to the patient as is necessary to enable the patient to participate in accordance with paragraph (c) above:
- (e) the range of options available in the patient's case;
- (f) the importance of providing the maximum benefit to the patient;
- (g) the need to ensure that, unless it can be shown that it is justified in the circumstances, the patient is not treated in a way that is less favourable than

- the way in which a person who is not a patient might be treated in a comparable situation;
- (h) the patient's abilities, background and characteristics, including, without prejudice to that generality, the patient's age, sex, sexual orientation, religious persuasion, racial origin, cultural and linguistic background and membership of any ethnic group.
- (4) After having regard to—
 - (a) the matters mentioned in subsection (3) above;
 - (b) if subsections (5) and (6) below apply, the matters mentioned there; and
 - (c) such other matters as are relevant in the circumstances.

the person shall discharge the function in the manner that appears to the person to be the manner that involves the minimum restriction on the freedom of the patient that is necessary in the circumstances.

- (5) Whenever a person who does not fall within subsection (7) below is discharging a function by virtue of this Act (other than the making of a decision about medical treatment) in relation to a patient, the person shall have regard, in so far as it is reasonable and practicable to do so, to—
 - (a) the needs and circumstances of any carer of the patient which are relevant to the discharge of the function and of which the person is aware; and
 - (b) the importance of providing such information to any carer of the patient as might assist the carer to care for the patient.
- (6) Whenever a person who does not fall within subsection (7) below is discharging a function by virtue of this Act in relation to a person who is, or has been, subject to—
 - (a) detention in hospital authorised by a certificate granted under section 36(1) of this Act (any such certificate being referred to in this Act as an "emergency detention certificate");
 - (b) detention in hospital authorised by a certificate granted under section 44(1) of this Act (any such certificate being referred to in this Act as a "short-term detention certificate");
 - (c) an order made under section 64(4)(a) of this Act (any such order being referred to in this Act as a "compulsory treatment order"); or
 - (d) an order made under [F1 section 57(2)(a) or 57A(2)] of the 1995 Act (any such order being referred to in this Act as a "compulsion order"),

the person who is discharging the function shall have regard to the importance of the provision of appropriate services to the person who is, or has been, subject to the certificate or order concerned (including, without prejudice to that generality, the provision of continuing care when the person is no longer subject to the certificate or order).

- (7) A person falls within this subsection if the person is discharging the function by virtue of being—
 - (a) the patient;
 - (b) the patient's named person;
 - (c) the patient's primary carer;
 - (d) a person providing independent advocacy services to the patient under section 259 of this Act;
 - (e) the patient's legal representative;
 - (f) a curator *ad litem* appointed by the Tribunal in respect of the patient;

- (g) a guardian of the patient; or
- (h) a welfare attorney of the patient.
- (8) In subsection (3)(a) above, the reference to wishes and feelings of the patient is a reference to those wishes and feelings in so far as they can be ascertained by any means of communication, whether human or by mechanical aid (whether of an interpretative nature or otherwise), appropriate to the patient.
- (9) The person need not have regard to the views of a person mentioned in subsection (3) (b) above in so far as it is unreasonable or impracticable to do so.
- (10) In subsection (3)(d) above, the reference to information is to information in the form that is mostly likely to be understood by the patient.
- (11) In this section, a reference to "discharging", in relation to a power, includes a reference to exercising the power by taking no action; and "discharge" shall be construed accordingly.

Welfare of the child

- (1) This section applies whenever a person who does not fall within section 1(7) of this Act is discharging a function, by virtue of this Act, to which subsection (2) or (3) below applies in relation to a patient who is under the age of 18 years.
- (2) This subsection applies to any duty which may be discharged in more than one manner.
- (3) This subsection applies to any power.
- (4) The person shall discharge the function in the manner that appears to the person to be the manner that best secures the welfare of the patient.
- (5) In determining the manner of discharging the function that best secures the welfare of the patient, the person shall have regard to—
 - (a) the matters mentioned in section 1(3) of this Act;
 - (b) the matters mentioned in section 1(5) and (6) of this Act (where those subsections apply); and
 - (c) the importance of the function being discharged in the manner that appears to the person to be the manner that involves the minimum restriction on the freedom of the patient that is necessary in the circumstances.
- (6) Subsections (8) to (10) of section 1 of this Act shall apply for the purpose of subsection (5)(a) above as they apply in relation to subsection (3) of that section.

3 Equal opportunities

- (3) The persons referred to in subsection (1) above are—
 - (a) the Scottish Ministers;
 - (b) the Commission;
 - (c) a local authority;
 - (d) a Health Board;
 - (e) a Special Health Board;
 - (f) a National Health Service trust;
 - [F2(fa) (as respects its health service functions only) Healthcare Improvement Scotland;]
 - (g) the managers of a hospital;
 - (h) a mental health officer;
 - (i) a patient's responsible medical officer;
 - (i) a medical practitioner; and
 - (k) a nurse.

Continued existence of Commission

4 The Mental Welfare Commission for Scotland

- (1) There shall continue to be a body corporate known as the Mental Welfare Commission for Scotland (in this Act referred to as "the Commission").
- (2) The Commission shall discharge such functions as are conferred on it by virtue of—
 - (a) this Act;
 - (b) the Adults with Incapacity (Scotland) Act 2000 (asp 4); and
 - (c) any other enactment.
- [F3(2A) In so discharging its functions, the Commission shall act in a manner which seeks to protect the welfare of persons who have a mental disorder.]
 - (3) Schedule 1 to this Act (which makes provision as respects the Commission) shall have effect.

- (1) The Commission must establish and maintain a committee to be known as the National Confidential Forum ("NCF") for the purpose of carrying out the following functions (referred to in this Act as "NCF functions")—
 - (a) the general functions mentioned in section 4ZB,
 - (b) the functions conferred on NCF in schedule 1A.
- (2) Schedule 1A makes further provision about NCF.

4ZB General functions of NCF

The general functions of NCF are—

- (a) to provide means for persons who were placed in institutional care as children to describe in confidence (such descriptions being referred to in this Act as "testimony")—
 - (i) experiences of that care,
 - (ii) any abuse experienced during the period spent in that care,
- (b) to acknowledge testimony by enabling it to be given at hearings established by NCF or by written or other means,
- (c) based on testimony received—
 - (i) to identify any patterns and trends in the experiences of persons placed in institutional care as children (including the causes, nature, scale and circumstances of any abuse experienced), and
 - (ii) to make recommendations about policy and practice which NCF considers will improve institutional care (including by protecting children from, and preventing or reducing the incidence of, abuse),
- (d) while preserving the anonymity of participants, establishments providing institutional care and other persons, to prepare reports of the testimony it receives and its recommendations in relation to them,
- (e) to provide information about advice and assistance available to persons giving, or proposing to give, testimony.

- (2) The person appointed to chair NCF (the "NCF Head") must account to the Commission for the carrying out of the NCF functions.
- (3) Subsections (1) and (2) do not affect the responsibility of the Commission for the carrying out of the NCF functions.

4A Commission Visitors

- (1) Commission Visitors are to exercise the functions conferred on them by this Act or any other enactment on behalf of the Commission.
- (2) Commission Visitors may, in addition to the other functions conferred in this Part, exercise the functions of the Commission mentioned in—
 - (a) section 8A of this Act;
 - (b) section 9(1)(d) of the Adults with Incapacity (Scotland) Act 2000 (asp 4).
- (3) The Commission may give the Commission Visitors directions of a general or specific nature in relation to the exercise of the functions conferred on them.
- (4) A Commission Visitor must—
 - (a) comply with any direction given under subsection (3); and
 - (b) act in accordance with any guidance issued by the Commission in relation to the exercise of the functions of Commission Visitors.
- (5) A Commission Visitor acting in the exercise of any function must, if required, produce evidence of the Commission Visitor's authority.
- (6) In this Act, "Commission Visitors" are persons appointed under paragraph 7A(1) or (2) of schedule 1 to this Act.]

5 Duty to monitor operation of Act and promote best practice

8 Duty to bring specific matters to attention of Scottish Ministers and others etc.

- (1) If it appears to the Commission that a relevant person has, or may have, powers or duties, the exercise or performance of which might prevent or remedy or assist in preventing or remedying, as respects a person who has a mental disorder, any of the circumstances mentioned in subsection (2) below, the Commission shall—
 - (a) bring the facts of the person's case to the attention of the relevant person; and

- (b) if it considers it appropriate to do so, make recommendations as respects the case to the relevant person.
- (2) Those circumstances are—
 - (a) the circumstances mentioned in section 11(2)(a), (d), (e) or (f) of this Act;
 - (b) that—
 - (i) the patient is detained in hospital and the detention is authorised by virtue of this Act or the 1995 Act; and
 - (ii) there may be some impropriety in relation to that detention.
- (3) For the purposes of subsection (1) above, "relevant person" means—
 - (a) the Scottish Ministers;
 - (b) the Public Guardian;
 - (c) a local authority;
 - (d) a Health Board;
 - (e) a Special Health Board;

- (1) The Commission shall, as it considers appropriate, raise any concerns (of a general or specific nature) about the provision of any service mentioned in subsection (2) as respects a person who has a mental disorder, with—
 - (a) Social Care and Social Work Improvement Scotland;
 - (b) Healthcare Improvement Scotland; or
 - (c) such other relevant persons, or group of persons.
- (2) The services are—
 - (a) any social service (within the meaning of Part 5 of the Public Services Reform (Scotland) Act 2010 (asp 8));
 - (b) health care (within the meaning of section 10A of the National Health Service (Scotland) Act 1978 (c. 29)).
- (3) In subsection (1), the "provision" of any service includes the organisation or coordination of any such service.]

12 Investigations: further provision

- (1) The Commission may, if it considers it appropriate to do so, cause an inquiry to be held for the purpose of carrying out an investigation, [F24 in relation to any of the circumstances mentioned in section 11(2)] of this Act, into any case.

CHAPTER 1

APPLICATION FOR, AND MAKING OF, ORDERS

Pre-application procedures

- (d) that because of the mental disorder the patient's ability to make decisions about the provision of such medical treatment is significantly impaired; and
- (e) that the making of a compulsory treatment order is necessary.
- (4) This subsection applies where each of the medical practitioners who carries out a medical examination mentioned in subsection (2) above submits to the mental health officer a report (any such report being referred to in this Act as a "mental health report")—
 - (a) stating that the medical practitioner submitting the report is satisfied that the conditions mentioned in paragraphs (a) to (e) of subsection (3) above are met in respect of the patient;
 - (b) stating, in relation to each of the conditions mentioned in paragraphs (b) to (e) of subsection (3) above, the medical practitioner's reasons for believing the condition to be met in respect of the patient;

 - (ii) vary the order; or

"Interim compulsion orders

53 Interim compulsion order

(1) This section applies where a person (referred to in this section and in sections 53A to 53D of this Act as an "offender")—

- (9) An interim compulsion order may include such directions as the court thinks fit for the removal of the offender to, and the detention of the offender in, a place of safety pending the offender's admission to the specified hospital.

57A Compulsion order

- (1) This section applies where a person (in this section and in sections [F13757B to] 57D of this Act, referred to as the "offender")—

it may, subject to subsection (5) below, make an order (in this Act referred to as a "compulsion order") authorising, subject to subsection (7) below, for the period of 6 months beginning with the day on which the order is made such of the measures mentioned in subsection (8) below as may be specified in the order.

 - (b) that medical treatment which would be likely to—

- (6) A compulsion order may authorise detention in a state hospital only if, on the written or oral evidence of the two medical practitioners mentioned in subsection (2)(a) above, it appears to the court—
 - (a) that the offender requires to be detained in hospital under conditions of special security; and
 - (b) that such conditions of special security can be provided only in a state hospital.
- (7) Where the court—
 - (a) makes a compulsion order in respect of an offender; and
 - (b) also makes a restriction order in respect of the offender,

the compulsion order shall authorise the measures specified in it without limitation of time.

- (g) the imposition of a requirement on the offender to obtain the approval of the mental health officer to any change of address; and
- (h) the imposition of a requirement on the offender to inform the mental health officer of any change of address before the change takes effect.
- (9) The court may make a compulsion order imposing, by virtue of subsection (8) (e) above, a requirement on an offender to reside at a specified place which is a place used for the purpose of providing a care home service only if the court is satisfied that the person providing the care home service is willing to receive the offender.
- (10) The Scottish Ministers may, by regulations made by statutory instrument, make provision for measures prescribed by the regulations to be treated as included among the measures mentioned in subsection (8) above.
- (11) The power conferred by subsection (10) above may be exercised so as to make different provision for different cases or descriptions of case or for different purposes.
- (12) No regulations shall be made under subsection (10) above unless a draft of the statutory instrument containing them has been laid before, and approved by a resolution of, the Scottish Parliament.

CHAPTER 2

ADVOCACY ETC.

Advocacy

259 Advocacy

- (1) Every person with a mental disorder shall have a right of access to independent advocacy; and accordingly it is the duty of—
 - (a) each local authority, in collaboration with the (or each) relevant Health Board; and
 - (b) each Health Board, in collaboration with the (or each) relevant local authority, to secure the availability, to persons in its area who have a mental disorder, of independent advocacy services and to take appropriate steps to ensure that those persons have the opportunity of making use of those services.
- (2) Each relevant Health Board and local authority shall, for the purposes of subsection (1) above, collaborate with the local authority or, as the case may be, Health Board in relation to which it is the relevant Board or authority.
- (3) For the purposes of subsections (1) and (2) above—
 - (a) a Health Board is, in relation to a local authority, a "relevant" Health Board if its area or part of its area is the same as or is included in the area of the local authority; and
 - (b) a local authority is, in relation to a Health Board, a "relevant" local authority if its area or part of its area is the same as or is included in the area of the Health Board.
- (4) In subsection (1) above, "advocacy services" are services of support and representation made available for the purpose of enabling the person to whom they are available to have as much control of, or capacity to influence, that person's care and welfare as is, in the circumstances, appropriate.
- (5) For the purposes of subsection (1) above, advocacy services are "independent" if they are to be provided by a person who is none of the following—
 - (a) a local authority;
 - (b) a Health Board:
 - (c) a National Health Service trust;
 - (d) a member of—
 - (i) the local authority;
 - (ii) the Health Board;
 - (iii) a National Health Service trust,

in the area of which the person to whom those services are made available is to be provided with them;

- (e) a person who—

Advance statements

275 Advance statements: making and withdrawal

- (1) An "advance statement" is a statement complying with subsection (2) below and specifying—
 - (a) the ways the person making it wishes to be treated for mental disorder;
 - (b) the ways the person wishes not to be so treated,

in the event of the person's becoming mentally disordered and the person's ability to make decisions about the matters referred to in paragraphs (a) and (b) above being, because of that, significantly impaired.

- (2) An advance statement complies with this subsection if—
 - (a) at the time of making it, the person has the capacity of properly intending the wishes specified in it;
 - (b) it is in writing;
 - (c) it is subscribed by the person making it;
 - (d) that person's subscription of it is witnessed by a person (the "witness") who is within the class of persons prescribed by regulations for the purposes of this paragraph and who signs the statement as a witness to that subscription; and
 - (e) the witness certifies in writing on the document which comprises the statement that, in the witness's opinion, the person making the statement has the capacity referred to in paragraph (a) above.
- (3) An advance statement may be withdrawn by the person who made it by a withdrawal complying with this subsection; and a withdrawal so complies if—
 - (a) at the time of making it the person has the capacity properly to intend to withdraw the statement; and
 - (b) it is made by means of a document which, were it an advance statement, would comply with paragraphs (b) to (e) of subsection (2) above.

276 Advance statements: effect

- (1) If the Tribunal is satisfied as to the matters set out in subsection (2) below, it shall, in making any decision in respect of a patient who is a person who has made and not withdrawn an advance statement, have regard to the wishes specified in the statement.
- (2) Those matters are—
 - (a) that, because of mental disorder, the ability of the person who made the advance statement to make decisions about the matters referred to in paragraphs (a) and (b) of subsection (1) of section 275 of this Act is significantly impaired;
 - (b) that the statement complies with subsection (2) of that section;
 - (c) that any measures or treatment which might or will be authorised by virtue of the decision referred to in subsection (1) above or might or will, by virtue of that decision, no longer be authorised correspond to any wishes specified in the statement; and
 - (d) that, since the person made the statement, there has been no change of circumstances which, were the person to have been considering making the statement at the time the Tribunal is making the decision referred to in subsection (1) above, would have been likely to cause the person not to make the statement or to make a substantially different one.
- (3) A person giving medical treatment authorised by virtue of this Act or the 1995 Act to a patient who is a person—
 - (a) who has made and not withdrawn an advance statement; and
 - (b) whose ability to make decisions about the matters referred to in paragraphs (a) and (b) of subsection (1) of section 275 of this Act is, because of mental disorder, significantly impaired,

shall have regard to the wishes specified in the advance statement.

 - (a) an advance statement shall be taken to comply with subsection (2) of section 275 of this Act; and
 - (b) a withdrawal of an advance statement shall be taken to comply with subsection (3) of that section,

unless the contrary appears.

293 Removal order

- (1) If, on the application of a relevant mental health officer, a sheriff is satisfied that—
 - (a) a person who is aged 16 years or over has a mental disorder;
 - (b) any of the circumstances mentioned in subsection (2) below apply in respect of that person; and

Absconding

301 Absconding etc. by patients subject to compulsory treatment order

- (1) A patient who is subject to a compulsory treatment order authorising detention in hospital and who—
 - (a) absconds from—
 - (i) any place where the patient is kept pending removal to hospital under the order; or
 - (ii) the hospital in which, under the order, the patient is being detained; or
 - (b) while being removed to hospital under the order or transferred under section 124 of this Act, absconds,

is liable to be taken into custody and dealt with in accordance with section 303 of this Act.

- (2) A patient who is subject to such an order and in respect of whom—
 - (a) a certificate under section 127(1) of this Act has effect; and
 - (b) a condition under subsection (6) of that section requires—
 - (i) that the patient be kept in the charge of an authorised person or reside continuously or for or at specified times at a specified place; or
 - (ii) that the patient, on being recalled or on the expiry of a specified period or on or after the occurrence of a specified event, return to the hospital in which the patient was detained under the order or go to such other place as may be specified,

and who absconds from the charge of that authorised person or otherwise fails to comply with the condition is liable to be taken into custody and dealt with in accordance with section 303 of this Act.

- (3) A patient who is subject to a compulsory treatment order imposing a requirement that the patient reside at a specified place and who fails to comply with that requirement is liable to be taken into custody and dealt with in accordance with section 303 of this Act.
- (4) A patient who is subject to a compulsory treatment order imposing a requirement that the patient obtain the approval of the mental health officer to any proposed change of address and who changes address without having obtained that approval is liable to be taken into custody and dealt with in accordance with section 303 of this Act.
- (5) A patient who has been taken into custody under this section and who absconds from that custody remains liable to be taken into custody and dealt with in accordance with section 303 of this Act.

304 Effect of unauthorised absence

- (1) References in this section and sections 305 to 308 of this Act to a patient's unauthorised absence are references to a patient's being liable, under section 301 of this Act, to be taken into custody and dealt with under section 303 of this Act.

323 Suspension of decision of Tribunal pending determination of certain appeals

- (2) The enactments mentioned in Part 1 of schedule 5 to this Act (which include provisions that are spent) are hereby repealed to the extent specified in the second column of that schedule.
- (3) The enactments mentioned in Part 2 of schedule 5 to this Act (which include provisions that are spent) are hereby revoked to the extent specified in the second column of that schedule.
