I^{FI}Effect of emergency detention certificate on certain ordersI

43 [F1Effect of emergency detention certificate on certain orders]

- (1) This section applies where—
 - (a) a patient is subject to a [F2relevant order]; and
 - (b) an emergency detention certificate is granted in respect of the patient.
- (2) [F3A relevant order] shall, subject to subsection (3) below, cease to authorise the measures specified in it for the period during which the patient is subject to the emergency detention certificate.
- (3) If the measure mentioned in section 66(1)(b) of this Act [F4 or (as the case may be) section 57A(8)(b) of the 1995 Act] is specified in the [F5 relevant order], the [F5 relevant order] shall continue to authorise that measure during the period mentioned in subsection (2) above.
- [^{F6}(4) In this section, the references to a relevant order are to—
 - (a) a compulsion order, or
 - (b) a compulsory treatment order or an interim compulsory treatment order.]
