# **HUMAN TISSUE (SCOTLAND) ACT 2006**

### **EXPLANATORY NOTES**

#### THE ACT - AN OVERVIEW

#### Part 7: General

# Section 58 – Ancillary provisions

144. Section 58 enables the Scottish Ministers to make further provision, by order, which is incidental to or consequent on the Act and to allow transitional or savings provisions as required in implementing the Act's provisions.

## Section 59 – Regulations or orders

145. Subsection (1) provides that powers to make orders or regulations in the Act are to be exercisable by statutory instrument. Subsection (2) provides that except where otherwise provided, the statutory instruments containing such orders or regulations shall be subject to negative procedure in the Scottish Parliament. Subsection (3) provides that regulations under section 55, an order under section 58 which contains provisions which alter the text of an Act and regulations under section 17(3), (4) or (5) are to be the subject of affirmative resolution.

### Section 60 – Interpretation

146. Section 60 defines terms used throughout the Act.

#### Section 61 – Repeals

147. Section 61 introduces schedule 1 (which contains consequential repeals).

# Section 62 - Short title and commencement

148. This section provides for the short title of the Act. Further, section 62 allows the Scottish Ministers to bring the provisions of the Act (except sections 52, 59, 60 and 62) into force by order and to set different dates to commence different provisions. The section provides for sections 52, 59, 60 and 62 to come into force on Royal Assent.
