[^{F1}THE COMMISSIONER FOR ETHICAL STANDARDS IN PUBLIC LIFE IN SCOTLAND]

Finance

20 Budget

- (1) The [^{F1}Commissioner] must, before the start of each financial year, prepare proposals for [^{F2}the Commissioner's] use of resources and expenditure during the year (a "budget") and, by such date as the Parliamentary corporation determines, send the budget to the Parliamentary corporation for approval.
- (2) The [^{F3}Commissioner] may, in the course of a financial year, prepare a revised budget for the remainder of the year and send it to the Parliamentary corporation for approval.
- (3) In preparing a budget or a revised budget, the [^{F4}Commissioner] must ensure that the resources of the [^{F4}Commissioner] will be used economically, efficiently and effectively.
- (4) A budget or revised budget must contain a statement that the [^{F5}Commissioner] has complied with the duty under subsection (3).
