The Social Security Benefits Up-rating Order (Northern Ireland) 2005

Made - - - - 10th March 2005

Coming into operation in accordance with Article 1

Whereas the Secretary of State has made an Order⁽¹⁾ under sections 150, 151 and 189(1), (4) and (5) of the Social Security Administration Act 1992⁽²⁾:

Now, therefore, the Department for Social Development, in exercise of the powers conferred by sections 132 and 165(1), (4) and (5) of the Social Security Administration (Northern Ireland) Act 1992⁽³⁾, and now vested in it⁽⁴⁾, and of all other powers enabling it in that behalf, hereby makes the following Order:

PART I

INTRODUCTION

Citation, commencement and effect

1.—(1) This Order may be cited as the Social Security Benefits Up-rating Order (Northern Ireland) 2005 and, subject to paragraph (2), shall come into operation for the purposes of—

- (a) Articles 1, 2 and 6 on 1st April 2005;
- (b) Article 8, in so far as it relates to a particular beneficiary, on the first day of the first benefit week to commence for that beneficiary on or after 1st April 2005 and, for the purpose

of this sub-paragraph, “benefit week” has the same meaning as in the Computation of Earnings Regulations;

- (c) Article 10 on 3rd April 2005, except for the purpose of determining the rate of maternity allowance in accordance with section 35A(1) of the Contributions and Benefits Act(5) for which purpose it shall come into operation on 11th April 2005;
- (d) Article 11 on 3rd April 2005;
- (e) Article 9 on 6th April 2005;
- (f) Articles 3 to 5, 7, 12, 13 and 24 on 11th April 2005;
- (g) Articles 14, 15 and 25 on 14th April 2005;
- (h) Articles 16 to 18, in so far as they relate to a particular beneficiary, on the first day of the first benefit week to commence for that beneficiary on or after 11th April 2005 and, for the purpose of this sub-paragraph, “benefit week” has the same meaning as in the Income Support Regulations;
- (i) Articles 19 and 20, in relation to a case where rent is payable at intervals of a week or any multiple thereof, on 4th April 2005, and in relation to any other case, on 1st April 2005; and
- (j) Articles 21 to 23, in so far as they relate to a particular beneficiary, on the first day of the first benefit week to commence for that beneficiary on or after 11th April 2005 and, for the purpose of this sub-paragraph, “benefit week” has the same meaning as in the Jobseeker’s Allowance Regulations.

(2) The increases made –

- (a) in the sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act; and
- (b) by Article 21(c), in so far as it is relevant for the purposes referred to in Article 6(11),

shall take effect for each case on the date specified in relation to that case in Article 6.

Interpretation

2. In this Order –

“the Administration Act” means the Social Security Administration (Northern Ireland) Act 1992;

“the Contributions and Benefits Act” means the Social Security Contributions and Benefits (Northern Ireland) Act 1992(6);

“the Pension Schemes Act” means the Pension Schemes (Northern Ireland) Act 1993(7);

“the Computation of Earnings Regulations” means the Social Security Benefit (Computation of Earnings) Regulations (Northern Ireland) 1996(8);

“the Housing Benefit Regulations” means the Housing Benefit (General) Regulations (Northern Ireland) 1987(9);

“the Income Support Regulations” means the Income Support (General) Regulations (Northern Ireland) 1987(10);

“the Jobseeker’s Allowance Regulations” means the Jobseeker’s Allowance Regulations (Northern Ireland) 1996(11);

“the State Pension Credit Regulations” means the State Pension Credit Regulations (Northern Ireland) 2003(12).

(2) The Interpretation Act (Northern Ireland) 1954(13) shall apply to this Order as it applies to an Act of the Assembly.

PART II

SOCIAL SECURITY BENEFITS AND PENSIONS

Rates or amounts of certain benefits under the Contributions and Benefits Act

3.—(1) The sums specified in paragraph (2) shall be increased from and including the respective dates specified in Article 6 so that Schedule 4 to the Contributions and Benefits Act (rates of benefit, etc.), except paragraph 5 of Part III of that Schedule (guardian’s allowance), has effect as set out in Schedule 1.

(2) The sums mentioned in paragraph (1) are the sums specified in Parts I, III, IV and V of Schedule 4 to the Contributions and Benefits Act except, in –

- (a) Part I, the sum specified for child’s special allowance;
- (b) Part III, the sum specified for –
 - (i) guardian’s allowance, and
 - (ii) age addition to a pension of any category, and otherwise under section 79 of that Act;
- (c) Part IV, the sums specified in column (2) (increase for qualifying child); and
- (d) Part V, the sums specified for the increase in disablement pension for dependent children, widow’s pension (initial rate) and death benefit allowance in respect of children.

Rates or amounts of certain pensions or allowances under the Contributions and Benefits Act

4.—(1) The sums specified in paragraphs (2) to (5) shall be increased from and including the respective dates specified in Article 6.

(2) The sums falling to be calculated under paragraph 13(4) of Schedule 7 to the Contributions and Benefits Act (calculation of weekly rate of a beneficiary’s retirement allowance) shall be increased by 3.1 per cent. of their amount apart from this Order.

(3) In section 44(4) of the Contributions and Benefits Act(14) (basic pension of Category A retirement pension) –

- (a) for “£71·15” there shall be substituted “£73·35”; and
 - (b) for “£79·60” there shall be substituted “£82·05”.
- (4) It is hereby directed that the sums which are –
- (a) the additional pensions in long-term benefits calculated by reference to any final relevant year earlier than the tax year 2004-05 shall be increased by 3·1 per cent. of their amount apart from this Order;
 - (b) the increases in the rates of retirement pensions under Schedule 5 to the Contributions and Benefits Act(15) (increase of pension where entitlement is deferred) shall be increased by 3·1 per cent. of their amount apart from this Order; and
 - (c) payable to a pensioner as part of his Category A or Category B retirement pension by virtue of an order made under section 120 of the Social Security (Northern Ireland) Act 1975(16), Article 64 of the Social Security (Northern Ireland) Order 1986(17) or section 132 of the Administration Act shall be increased by 3·1 per cent. of their amount apart from this Order.
- (5) The sums which are shared additional pensions under section 55A of the Contributions and Benefits Act(18), and the sums which are increases in the rates of such pensions under section 55C of that Act, shall in each case be increased by 3·1 per cent. of their amount apart from this Order.

Rates or amounts of certain benefits under the Pension Schemes Act

5.—(1) It is hereby directed that the sums specified in paragraph (2) shall be increased from and including the respective dates specified in Article 6.

(2) Sums which are payable by virtue of section 11(1) of the Pension Schemes Act (increase of guaranteed minimum where commencement of guaranteed minimum pension is postponed) to a person who is also entitled to a Category A or Category B retirement pension (including sums payable by virtue of section 13(2) of that Act) shall be increased by –

- (a) 3·1 per cent. of their amount apart from this Order where the increase under section 11(1) is attributable to earnings factors for the tax year 1987-88 and earlier tax years(19); and
- (b) 0·1 per cent. of their amount apart from this Order where the increase under section 11(1) is attributable to earnings factors for the tax years 1988-89 to 1996-97 inclusive.

Dates on which sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act are increased by this Order

6.—(1) Paragraphs (2) to (9), which are subject to the provisions of paragraphs (10) and (11), specify the date on which the increases made by this Order in the sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act shall take effect for each case.

(2) Subject to paragraph (3), any increases in the sums specified in Articles 3, 4 and 12 for Category A and Category B retirement pension and graduated retirement benefit together with, where appropriate, increases for dependants, shall take effect on 11th April 2005.

(3) In the case of a person over pensionable age whose entitlement to a Category A retirement pension is deferred and for whom the rate of short-term incapacity benefit falls to be calculated in accordance with section 30B(3) of the Contributions and Benefits Act(20), any increases in the sums mentioned in Articles 3, 4 and 12 for Category A and Category B retirement pension and graduated retirement benefit together with, where appropriate, any increases for dependants, shall take effect on 14th April 2005.

(4) The increases in the sums mentioned in Articles 4(4)(c) and 5(2) shall take effect on 11th April 2005.

(5) Any increases in the sums specified for the rate of maternity allowance, widowed mother's allowance and widowed parent's allowance, Category C and Category D retirement pension, child's special allowance(21), attendance allowance and carer's allowance (except in a case where the Department has made arrangements for it to be paid on a Wednesday) together with, in each case where appropriate, increases for dependants, shall in all cases take effect on 11th April 2005.

(6) Any increases in the sums specified for the rate of carer's allowance in a case where the Department has made arrangements for it to be paid on a Wednesday, together with, where appropriate, increases for dependants, disablement benefit together with increases of disablement pension, maximum disablement gratuity under paragraph 9(2) of Schedule 7 to the Contributions and Benefits Act, industrial death benefit by way of widow's and widower's pension and allowance in respect of children together with, where appropriate, increases for dependants, and the maximum of the aggregate of weekly benefit payable for successive accidents under section 107(1) of that Act, shall in all cases take effect on 13th April 2005.

(7) In any case where a person's weekly rate of Category A or Category B retirement pension falls to be increased under the provisions of section 47(1) or 48C(2) of the Contributions and Benefits Act(22), by reference to the weekly rate of invalidity allowance or age addition to long-term incapacity benefit to which he was previously entitled, any increase in such sum shall take effect on 11th April 2005.

(8) The increases in the sums specified for the rate of incapacity benefit and severe disablement allowance together with, where appropriate, any increases for dependants, shall take effect in all cases on 14th April 2005.

(9) The increases in the sums falling to be calculated in accordance with paragraph 13(4) of Schedule 7 to the Contributions and Benefits Act (retirement allowance) shall take effect on 13th April 2005.

(10) In the case of a person who is subject to the provisions of regulations made under section 71(1)(b) of the Administration Act(23) (adjustment of benefit for persons undergoing medical or other treatment as an in-patient in a hospital) the increase in the sum mentioned in Article 4(3)(b) shall take effect in that case on the day on which the increase in the benefit payable to him apart from those regulations takes effect.

(11) Any increases in the sums specified in Articles 3 and 21(c), in so far as those sums are relevant for the purposes of establishing whether the rate of any benefit is not to be increased in respect of an adult dependant because the earnings of the dependant exceed a specified amount, shall take effect –

- (a) except in a case where sub-paragraph (b) applies, on the first day of the first benefit week to commence for the beneficiary on or after 11th April 2005;
- (b) in a case where regulation 7(b) of the Computation of Earnings Regulations (date on which earnings are treated as paid) applies, on the first day of the first benefit week to commence for the beneficiary on or after 1st April 2005,

and for the purposes of this paragraph “benefit week” has the same meaning as in regulation 2(1) of the Computation of Earnings Regulations.

Workmen’s compensation

7. In paragraph 2(6)(c) of Schedule 8 to the Contributions and Benefits Act (maximum weekly rate of lesser incapacity allowance supplementing workmen’s compensation) for “£44·35” there shall be substituted “£47·70”.

Earnings limits

8. In section 80(4) of the Contributions and Benefits Act(24) (earnings limits in respect of child dependency increases) –

- (a) in paragraph (a) for “£165” there shall be substituted “£170”; and
- (b) in paragraph (b) for “£165” and “£21” there shall be substituted “£170” and “£22” respectively.

Statutory sick pay

9. In section 153(1) of the Contributions and Benefits Act (rate of payment) for “£66·15” there shall be substituted “£68·20”.

Statutory maternity pay

10. In regulation 6 of the Statutory Maternity Pay (General) Regulations (Northern Ireland) 1987(25) (prescribed rate of statutory maternity pay) for “£102·80” there shall be substituted “£106·00”.

Statutory paternity pay and statutory adoption pay

11. In the Statutory Paternity Pay and Statutory Adoption Pay (Weekly Rates) Regulations (Northern Ireland) 2002(26) –

- (a) in regulation 2(a) (weekly rate of payment of statutory paternity pay) for “£102·80” there shall be substituted “£106·00”; and
- (b) in regulation 3(a) (weekly rate of payment of statutory adoption pay) for “£102·80” there shall be substituted “£106·00”.

Graduated retirement benefit

12.—(1) The sum of 9·63 pence referred to in section 35(1) of the National Insurance Act (Northern Ireland) 1966⁽²⁷⁾ (graduated retirement benefit) shall be increased by 3·1 per cent. and accordingly the reference in that provision to that sum shall have effect as a reference to 9·93 pence.

(2) The sums which are the increases of graduated retirement benefit under Schedule 2 to the Social Security (Graduated Retirement Benefit) (No. 2) Regulations (Northern Ireland) 1978⁽²⁸⁾ (increases for deferred entitlement to a Category A or Category B retirement pension) shall be increased by 3·1 per cent. of their amount apart from this Order.

(3) The sums which are the additions under section 36(1) of the National Insurance Act (Northern Ireland) 1966 (special provision as to graduated retirement benefit for widows and widowers) shall be increased by 3·1 per cent. of their amount apart from this Order.

Disability living allowance

13. In regulation 4 of the Social Security (Disability Living Allowance) Regulations (Northern Ireland) 1992⁽²⁹⁾ (rate of benefit) –

- (a) in paragraph (1)(a) for “£58·80” there shall be substituted “£60·60”;
- (b) in paragraph (1)(b) for “£39·35” there shall be substituted “£40·55”;
- (c) in paragraph (1)(c) for “£15·55” there shall be substituted “£16·05”;
- (d) in paragraph (2)(a) for “£41·05” there shall be substituted “£42·30”; and
- (e) in paragraph (2)(b) for “£15·55” there shall be substituted “£16·05”.

Age addition to long-term incapacity benefit

14. In regulation 9(2) of the Social Security (Incapacity Benefit) Regulations (Northern Ireland) 1994⁽³⁰⁾ (increase in rate of incapacity benefit where beneficiary is under prescribed age on the qualifying date) –

- (a) in sub-paragraph (a) for “£15·55” there shall be substituted “£16·05”; and
- (b) in sub-paragraph (b) for “£7·80” there shall be substituted “£8·05”.

Transitional invalidity allowance in long-term incapacity benefit cases

15. In regulation 18(2) of the Social Security (Incapacity Benefit) (Transitional) Regulations (Northern Ireland) 1995⁽³¹⁾ (rate of long-term incapacity benefit in transitional cases) –

- (a) in sub-paragraph (a) for “£15·55” there shall be substituted “£16·05”;
- (b) in sub-paragraph (b) for “£10·00” there shall be substituted “£10·30”; and
- (c) in sub-paragraph (c) for “£5·00” there shall be substituted “£5·15”.

PART III

INCOME SUPPORT AND HOUSING BENEFIT

Applicable amounts for income support

16.—(1) The sums relevant to the calculation of an applicable amount as specified in the Income Support Regulations(**32**) shall be the sums set out in the following provisions of this Article and Schedules 2 to 5 to this Order; and for this purpose a reference in this Article to a numbered regulation or Schedule is a reference to the regulation of, or Schedule to, the Income Support Regulations bearing that number.

(2) In regulations 17(1)(b), 18(1)(c), 21(1) and 71(1)(a)(ii) and (d)(i) and paragraphs 13A(2)(a)(**33**) and 14(a) of Part III of Schedule 2, the sum specified is in each case £3,000.

(3) The sums specified in Part I of Schedule 2 (applicable amounts: personal allowances) shall be as set out in Schedule 2 to this Order.

(4) In paragraph 3 of Part II of Schedule 2(**34**) (applicable amounts: family premium) –

(a) in sub-paragraph (1)(a) for “£15·95” there shall be substituted “£16·10”; and

(b) in sub-paragraph (1)(b) for “£15·95” there shall be substituted “£16·10”.

(5) The sums specified in Part IV of Schedule 2 (applicable amounts: weekly amounts of premiums) shall be as set out in Schedule 3 to this Order.

(6) In paragraph 18 of Schedule 3(**35**) (housing costs: non-dependant deductions) –

(a) in sub-paragraph (1) the sums of £47·75 and £7·40 remain the same;

(b) in sub-paragraph (2)(a) for “£97·00” there shall be substituted “£101·00”;

(c) in sub-paragraph (2)(b) for “£97·00” and “£144·00” there shall be substituted “£101·00” and “£150·00” respectively and the sum of £17·00 remains the same;

(d) in sub-paragraph (2)(c) for “£144·00” and “£186·00” there shall be substituted “£150·00” and “£194·00” respectively and the sum of £23·35 remains the same;

(e) in sub-paragraph (2)(d) for “£186·00” and “£247·00” there shall be substituted “£194·00” and “£258·00” respectively and the sum of £38·20 remains the same; and

(f) in sub-paragraph (2)(e) for “£247·00” and “£308·00” there shall be substituted “£258·00” and “£322·00” respectively and the sum of £43·50 remains the same.

(7) Those sums relevant to the calculation of an applicable amount which are specified in Schedule 7 (applicable amounts in special cases) shall be as set out in Schedule 4 to this Order.

(8) The sums specified in any provision of the Income Support Regulations set out in column (1) of Schedule 5 to this Order are the sums set out in column (2) of that Schedule.

(9) In paragraph 19(b) of Schedule 9(**36**) (sums to be disregarded in the calculation of income other than earnings) for “£9·80” there shall be substituted “£10·55”.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order, which corresponds to an Order ([S.I. 2005/522](#)) made by the Secretary of State for Work and Pensions under section 150 of the Social Security Administration Act 1992, increases the rates and amounts of certain social security benefits and other sums.

Part I relates to citation, commencement, effect and interpretation.

Part II relates to non income-related benefits other than jobseeker's allowance.

Article 3 and Schedule 1 increase the rates of benefits and increases of benefit (except those referred to in Article 3(2)) specified in Parts I, III, IV and V of Schedule 4 to the Social Security Contributions and Benefits (Northern Ireland) Act 1992 ("the Contributions and Benefits Act").

Article 4 increases the rates and amounts of certain pensions and allowances under the Contributions and Benefits Act.

Article 5 increases the sums payable as part of a Category A or Category B retirement pension under sections 11(1) and 13(2) of the Pension Schemes (Northern Ireland) Act 1993 ("the Pension Schemes Act") on account of increases in guaranteed minimum pensions.

Article 6 specifies the dates from which the sums specified for rates or amounts of benefit under the Contributions and Benefits Act or the Pension Schemes Act are increased.

Article 7 increases the rate of certain workmen's compensation in respect of employment before 5th July 1948.

Article 8 specifies earnings limits for child dependency increases.

Article 9 increases the rate of statutory sick pay.

Article 10 specifies the rate of statutory maternity pay.

Article 11 specifies the rates of statutory paternity pay and statutory adoption pay.

Article 12 increases the rate of graduated retirement benefit.

Article 13 increases the rates of disability living allowance.

Article 14 increases the rates of age addition to long-term incapacity benefit.

Article 15 increases the rates of transitional invalidity allowance in long-term incapacity benefit cases.

Part III relates to income support and housing benefit.

Article 16 sets out the sums relevant to the applicable amount for the purposes of income support. Article 16(3) and Schedule 2 set out the personal allowances; Article 16(4) and (5) and Schedule 3 set out the premiums; Article 16(7) and Schedule 4 set out the amounts relevant to special cases; and Article 16(8) and Schedule 5 set out other miscellaneous amounts.

Article 17 provides for the percentage increase of sums payable by way of special transitional additions to income support.

Article 18 increases the sum by which any income support of a person involved in a trade dispute is reduced.

Article 19 sets out the sums relevant to the applicable amount for the purposes of housing benefit. Article 19(7) and Schedule 6 set out the personal allowances and Article 19(8) and (9) and Schedule 7 set out the premiums.

Article 20 sets out the sums relevant to the applicable amount for the purposes of housing benefit for certain persons over the qualifying age for state pension credit. Article 20(5) and Schedule 8 set out the personal allowances and Article 20(6) and (7) and Schedule 9 set out the premiums.

Part IV relates to jobseeker's allowance.

Article 21 increases the age-related amounts of contribution-based jobseeker's allowance.

Article 22 sets out the sums relevant to the applicable amount for the purposes of income-based jobseeker's allowance. Article 22(3) and Schedule 10 set out the personal allowances; Article 22(4) and (5) and Schedule 11 set out the premiums; Article 22(6) and Schedule 12 set out the amounts of premiums relevant to joint-claim couples; Article 22(8) and Schedule 13 set out the amounts relevant to special cases; Article 22(9) and Schedule 14 set out the amounts relevant to joint-claim couples in special cases; and Article 22(11) and Schedule 15 set out other miscellaneous amounts.

Article 23 increases the sum by which any income-based jobseeker's allowance of a person involved in a trade dispute is reduced.

Part V relates to state pension credit.

Article 24 and Schedule 16 specify sums relevant to state pension credit.

Part VI relates to a revocation.

Article 25 makes a consequential revocation.
