- **1.** This Order may be cited as the Justice (Northern Ireland) Act 2002 (Commencement No.11) Order 2006.
- **2.** The provisions of the Justice (Northern Ireland) Act 2002 specified in the Schedule to this Order shall come into force on 3rd April 2006.
