# The Forestry (2010 Act) (Commencement No. 1) Order (Northern Ireland) 2010

*Made - - - 8th September 2010* 

The Department of Agriculture and Rural Development(1), makes the following Order in exercise of the powers conferred by section 39(1) of the Forestry Act (Northern Ireland) 2010(2).

#### Citation and interpretation

- **1.**—(1) This Order may be cited as the Forestry (2010 Act) (Commencement No. 1) Order (Northern Ireland) 2010.
  - (2) In this Order "the Act" means the Forestry Act (Northern Ireland) 2010.

#### **Appointed Day**

**2.** 13th September 2010 is the day appointed for the coming into operation of the provisions of the Act listed in the Schedule.
