## Preliminary

The provisions of this Schedule identify the areas which constitute counties in England, counties in Wales or areas in Scotland for the purposes of the lieutenancies in Great Britain.

# Counties in England

- 2 The counties in England for the purposes of this Act are—
  - (a) Greater London (excluding the City of London);
  - (b) the areas which are to be regarded as counties for those purposes by virtue of paragraph 3; and
  - (c) any other areas in England which are counties for the purposes of the M1Local Government Act 1972.

#### Areas in Scotland

- 7 The areas in Scotland for the purposes of this Act are—
  - (a) the cities of Aberdeen, Dundee, Edinburgh and Glasgow; and
  - (b) the areas specified in an Order in Council under paragraph 8.
- 8 Her Majesty may by Order in Council divide Scotland (apart from the cities of Aberdeen, Dundee, Edinburgh and Glasgow) into such areas for the purposes of this Act as She thinks fit.
- Any deputy lieutenant who, immediately before the date on which an Order in Council under paragraph 8 is made, holds office for an area affected by the Order shall (without prejudice to any power of removal or directing removal from any office) continue to hold office on and after that date as deputy lieutenant for the area in which he resides or for such other area as may be specified in the Order.
