In the exercise of the powers conferred by section 43(3), (7) and (8) of the Special Educational Needs and Disability Act 2001(1), the Secretary of State for Education and Skills hereby makes the following Order:

Citation and interpretation

- **1.** This Order may be cited as the Special Educational Needs and Disability Act 2001 (Commencement No. 4) Order 2002.
- **2.** In this Order, unless the context otherwise requires, references to sections and Schedules are references to sections of and Schedules to the Special Educational Needs and Disability Act 2001.

Appointed days

- **3.** The day appointed for the coming into force of the provisions specified in Part I of the Schedule to this Order is 1st July 2002.
- **4.** The day appointed for the coming into force of the provisions specified in Part II of the Schedule to this Order, otherwise than as respects Wales(2), is 1st July 2002.
