**The Tax Credits, Child Benefit and Guardian's  
Allowance Up-rating Regulations 2024**

*Made - - - - 29th February 2024  
Coming into force in accordance with regulation 1(2)  
and (3)*

Following a review under section 41(1) of the Tax Credits Act 2002<sup>(1)</sup> in the year 2023-24 of the amounts specified in section 41(2) of that Act, the Treasury have determined that Regulations should be made prescribing increases to those amounts.

Following a review of the sums specified in section 150(1)(a)(i) and (1)(i) of the Social Security Administration Act 1992<sup>(2)</sup> in the tax year 2023-24, the Treasury have determined that the general level of prices in Great Britain is greater at the end of the period under review than it was at the beginning. These Regulations make provision under section 150 of the Social Security Administration Act 1992 and make corresponding provision for Northern Ireland in accordance with section 132(1) of the Social Security Administration (Northern Ireland) Act 1992<sup>(3)</sup>.

A draft of these Regulations was laid before Parliament in accordance with section 66(1) and (2) (a) of the Tax Credits Act 2002<sup>(4)</sup>, sections 150(2) and 190(1) of the Social Security Administration Act 1992<sup>(5)</sup>, and section 166(10A) of the Social Security Administration (Northern Ireland) Act 1992<sup>(6)</sup>, and approved by a resolution of each House of Parliament.

The Treasury make the following Regulations in exercise of the powers conferred by sections 7, 9, 11, 13, 65(1) and 67 of the Tax Credits Act 2002<sup>(7)</sup>, section 150(2), (5), (9) and (10)(a)

### **Citation, commencement and effect**

1.—(1) These Regulations may be cited as the Tax Credits, Child Benefit and Guardian’s Allowance Up-rating Regulations 2024.

(2) This regulation and regulations 2, 3 and 4 come into force on 6th April 2024.

(3) Regulations 5, 6 and 7 come into force on 8th April 2024.

(4) Regulations 2, 3 and 4 have effect in relation to awards of tax credits for the tax year beginning on 6th April 2024 and subsequent tax years.

### **Amendment of the Working Tax Credit (Entitlement and Maximum Rate) Regulations 2002**

2. The table in Schedule 2 (maximum rates of the elements of a working tax credit) to the Working Tax Credit (Entitlement and Maximum Rate) Regulations 2002(10) is amended as follows—

- (a) in item 1 (basic element), in the second column for “£2,280” substitute “£2,435”;
- (b) in item 2 (disability element), in the second column for “£3,685” substitute “£3,935”;
- (c) in item 3 (30 hours element), in the second column for “£950” substitute “£1,015”;
- (d) in items 4 (second adult element) and 5 (lone parent element), in the second column for “£2,340” substitute “£2,500”; and
- (e) in item 6 (severe disability element), in the second column for “£1,595” substitute “£1,705”.

### **Amendment of the Child Tax Credit Regulations 2002**

3. Regulation 7 (determination of the maximum rate at which a person or persons may be entitled to child tax credit) of the Child Tax Credit Regulations 2002(11) is amended as follows—

- (a) in paragraph (4)(c) and 4(f) for “£3,235” substitute “£3,455”; and
- (b) in paragraph (5)—
  - (i) in sub-paragraph (a) for “£3,905” substitute “£4,170”; and
  - (ii) in sub-paragraph (b) for “£5,480” substitute “£5,850”.

### **Amendment of the Tax Credits (Income Thresholds and Determination of Rates) Regulations 2002**

4.—(1) The Tax Credits (Income Thresholds and Determination of Rates) Regulations 2002(12) are amended as follows.

The functions of the Department for Social Development (renamed as the Department for Communities by the Departments Act (Northern Ireland) 2016 (c. 5)), in respect of child benefit and guardian’s allowance, under section 132 of the Social Security Administration (Northern Ireland) Act 1992 were transferred to the Treasury by section 49(4) of the Tax Credits Act 2002. Section 132(1) was amended by paragraph 9 of Schedule 4 to the Tax Credits Act 2002.

(2) In regulation 3 (manner in which amounts to be determined for the purposes of section 7(1) (a) of the Act)—

- (a) in paragraph (2) for “£7,455” substitute “£7,955”; and
- (b) in paragraph (3) for “£18,725” substitute “£19,995”.

(3) In regulation 7(3) (determination of rate of working tax credit) in Step 4 for “£6,770” substitute “£7,995”.

(4) In regulation 8(3) (determination of rate of child tax credit) in Step 4 for “£17,005” substitute “£19,995”.

#### **Amendment of the Child Benefit (Rates) Regulations 2006**

5. Regulation 2(1) (rate of child benefit) of the Child Benefit (Rates) Regulations 2006<sup>(13)</sup> is amended as follows—

- (a) in sub-paragraph (a) (enhanced rate) for “£24.00” substitute “£25.60”; and
- (b) in sub-paragraph (b) (other cases) for “£15.90” substitute “£16.95”.

#### **Amendment of Schedule 4 to the Social Security Contributions and Benefits Act 1992**

6. In paragraph 5 of Part 3 of Schedule 4 to the Social Security Contributions and Benefits Act 1992 (weekly rate of guardian’s allowance)<sup>(14)</sup> for “£20.40” substitute “£21.75”.

#### **Amendment of Schedule 4 to the Social Security Contributions and Benefits (Northern Ireland) Act 1992**

7. In paragraph 5 of Part 3 of Schedule 4 to the Social Security Contributions and Benefits (Northern Ireland) Act 1992 (weekly rate of guardian’s allowance)<sup>(15)</sup> for “£20.40” substitute “£21.75”.

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the Working Tax Credit (Entitlement and Maximum Rate) Regulations 2002 (S.I. 2002/2005); the Child Tax Credit Regulations 2002 (S.I. 2002/2007); the Tax Credits (Income Thresholds and Determination of Rates) Regulations 2002 (S.I. 2002/2008); the Child Benefit (Rates) Regulations 2005 (S.I. 2006/965); the Social Security Contributions and Benefits Act 1992 (c.4); and the Social Security Contributions and Benefits (Northern Ireland) Act 1992 (c.7).

Regulation 2 increases the maximum rate of different elements of working tax credit. It increases the basic element from £2,280 to £2,435, the disability element from £3,685 to £3,935, the 30 hour element from £950 to £1,015, the second adult element and the lone parent element from £2,340 to £2,500, and the severe disability element from £1,595 to £1,705.

Regulation 3 increases the maximum rate of different elements of child tax credit. It increases the individual element from £3,235 to £3,455 for a child or qualifying young person. It increases the disability element from £3,905 to £4,170 for a disabled child or qualifying young person and from £5,480 to £5,850, for a severely disabled child or qualifying young person.

Regulation 4 increases the income threshold (the level of household income below which the full award is granted) from £7,455 to £7,955 for working tax credit and from £18,725 to £19,995, for child tax credit. It also amends the formulae to calculate the rates of working tax credit and child tax credit to account for the increase in the income thresholds.

Regulation 5 increases the weekly rate of child benefit from £24.00 to £25.60 (enhanced rate) and from £15.90 to £16.95 (other cases).

Regulations 6 and 7 increase the weekly rate of guardian's allowance from £20.40 to £21.75.

The increase in the rates of child benefit and the increase made to the guardian's allowance take effect from the week beginning with the first Monday in the tax year 2024-25. The increase in the rates of tax credits take effect from the start of the tax year 2024-25.

In accordance with section 150(8) of the Social Security Administration Act 1998 (c. 5), a copy of the report by the Government Actuary giving their opinion on the likely effect on the National Insurance Fund of the making of these Regulations (in relation to the increases made to guardian's allowance) was laid before Parliament with the draft of these Regulations.

A full impact assessment has not been produced for this instrument as no impact on the private, voluntary, or public sectors is foreseen.
