

COMMISSION DECISION

of 30 July 1990

amending Decision 82/913/EEC as regards the list of establishments in the Republic of South Africa approved for the purpose of importing fresh meat into the Community

(90/433/EEC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Directive 72/462/EEC of 12 December 1972 on health and veterinary inspection problems upon importation of bovine animals and swine and fresh meat or meat products from third countries ⁽¹⁾, as last amended by Directive 89/662/EEC ⁽²⁾, and in particular Articles 4 (1) and 18 (1) thereof,

Having regard to Council Directive 77/96/EEC of 21 December 1976 on the examination for trichinae (*trichinella spiralis*) upon importation from third countries of fresh meat derives from domestic swine ⁽³⁾, as last amended by Commission Directive 89/321/EEC ⁽⁴⁾, and in particular Article 4 thereof,

Whereas a list of establishments in the Republic of South Africa and Namibia, approved for the purpose of importing fresh meat into the Community, was drawn up initially by Commission Decision 82/913/EEC ⁽⁵⁾, as last amended by Decision of 3 November 1989;

Whereas Namibia has become independent, it is necessary to amend Decision 82/913/EEC concerning the list of establishments in the Republic of South Africa and Namibia approved for the purpose of importing fresh meat into the Community;

Whereas the measures provided for in this Decision are in accordance with the opinion of the Standing Veterinary Committee,

HAS ADOPTED THIS DECISION:

Article 1

1. The Title of Decision 82/913/EEC is hereby replaced by the following text:

'Commission Decision 82/913/EEC establishing the list of establishments in the Republic of South Africa approved for the purpose of importing fresh meat into the Community.'

2. The Annex to Decision 82/913/EEC is hereby replaced by the Annex to this Decision.

Article 2

This Decision is addressed to the Member States.
