## SCHEDULE 1

(introduced by section 4)

### DISQUALIFICATION FROM MEMBERSHIP OF THE BOARD

- 1 The following persons are disqualified from being members of the Board—
- (a) [<sup>F1</sup>a Member of the Senedd],
  - (b) the Counsel General (if not [<sup>F1</sup>a Member of the Senedd]),
  - (c) a candidate for election as [<sup>F1</sup>a Member of the Senedd],
  - (d) a person whose name could, if the seat of a [<sup>F2</sup>regional Member of the Senedd] became vacant, be required to be notified to the Presiding Officer under section 11 of the Act (electoral region vacancies),
  - (e) a member of the European Parliament, House of Commons, <sup>F3</sup>... Scottish Parliament or Northern Ireland Assembly,
  - (f) a member of the staff of the [<sup>F4</sup>Senedd],
  - (g) a member of the staff of the Welsh <sup>F5</sup>... Government,
  - (h) a person employed by [<sup>F1</sup>a Member of the Senedd] or by a [<sup>F6</sup>group of Members] for the purpose of assisting that member or the members of that group to perform the functions of [<sup>F1</sup>a Member of the Senedd],
  - (i) the Auditor General for Wales,
  - (j) the [<sup>F7</sup>Senedd] Commissioner for Standards,
  - (k) a member of the [<sup>F4</sup>Senedd] Commission Corporate Governance Committee,
  - (l) a person holding the appointment of Independent Adviser to the [<sup>F4</sup>Senedd] Commission,
  - <sup>F8</sup>(m) .....
  - (n) a person holding the appointment of Non-Executive Director of the Welsh <sup>F9</sup>... Government.

  - (b) on the day on which that person is nominated as a candidate at [<sup>F10</sup>a Senedd] election,
- whichever is the earlier.
