Studies for improving economy, efficiency and effectiveness

26.—(1) [^{F1}The local government auditor may and, if required by the Department, shall] undertake comparative and other studies designed to enable him to make recommendations for improving economy, efficiency and effectiveness in the provision of services by local government bodies.

(2) [^{F2}Before undertaking any study under paragraph (1) the local government auditor shall consult] —

- (a) such councils;
- (b) such associations or bodies representative of councils;
- (c) such associations or bodies representative of officers of councils; and
- (d) such other persons or bodies,

as appear to the ^{F3}... local government auditor to be appropriate.

(3) Where a study under paragraph (1) is required by the Department, the local government auditor F4 ... shall report the results of the study and any recommendations made by him as a result of the study to the Department and the Department shall publish or otherwise make available any such results and recommendations.

 $[^{F5}(4)$ Except in the case of a study required by the Department, the local government auditor shall publish or otherwise make available—

- (a) the results of the study; and
- (b) any recommendations made by the local government auditor as a result of the study.]
