Obligations of trustees of occupational pension schemes

[F1Requirement for [F2an effective system of governance]

- **226A.**—[^{F3}(1) The trustees or managers of an occupational pension scheme must establish and operate an effective system of governance including internal controls.
- (1A) The system of governance must be proportionate to the size, nature, scale and complexity of the activities of the occupational pension scheme.]
- (2) Nothing in this Article affects any other obligation of the trustees or managers of an occupational pension scheme to establish or operate [F4 an effective system of governance including internal controls], whether imposed by or by virtue of any statutory provision, the scheme rules or otherwise.
