##### *The Road Traffic (Northern Ireland) Order 1981 (NI 1)*

**15.** In Article 19G (revocation of authorisation conferred by Great Britain licence because of disability or prospective disability)–

- (a) in paragraph (1) omit the words from “together” to the end;
- (b) in paragraph (2)–
  - (i) in sub-paragraph (a) omit “together with [<sup>F1</sup>its counterpart (if any) issued to him under this Part] ”; and
  - (ii) in sub-paragraph (b) omit “and [<sup>F2</sup>its counterpart (if any)] ”;
- (c) in paragraph (4) omit “and the [<sup>F3</sup>counterpart (if any)] ”;
- (d) omit paragraph (5);
