ROAD TRAFFIC AND VEHICLES

Road Traffic (Traffic Wardens) Order (Northern Ireland) 1976

10th February 1976 Made 1st April 1976 Coming into operation

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

The Department of the Environment for Northern Ireland in exercise of the powers conferred by section 102 of the Road Traffic Act (Northern Ireland) 1970(a) (hereinafter referred to as "the Act") and now vested in it(b) and of every other power enabling it in that behalf hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Road Traffic (Traffic Wardens) Order (Northern Ireland) 1976 and shall come into operation on 1st April 1976.

Functions of traffic wardens

- 2.—(1) The functions set out in the Schedule are hereby prescribed, for the purpose of authorising their discharge by traffic wardens under section 102 of the Act, as being functions in connection with the control and regulation of, or the enforcement of the law relating to, traffic (including pedestrians) or vehicles on roads or other public places.
- (2) For the purpose of the discharge by traffic wardens of the functions set out in the Schedule, references to a constable in sections 137, 154, 155 and 156(1A) of the Act and the reference to a member of the Royal Ulster Constabulary in section 27(1)(a) of the Vehicles (Excise) Act (Northern Ireland) 1972(c) shall include references to a traffic warden.
- (3) For the purpose of the discharge by traffic wardens of the functions set out in the Schedule, references to a constable in section 153 of the Act shall, in so far as it applies to the furnishing of names and addresses, include references to a traffic warden if the traffic warden has reasonable cause to believe that there has been committed an offence-
 - (a) under section 40 of the Act (failure to comply with requirements as to lighting of vehicles);
 - (b) in respect of a vehicle by its waiting, or being left parked, or being loaded or unloaded, in a road;
 - (c) under section 137 or 156(1A) of the Act (contravention of traffic directions and power of police to stop vehicles);
 - (d) under section 98 of the Act (offences relating to parking places on roads where charges made):
 - (e) under section 12(4) of the Vehicles (Excise) Act (Northern Ireland) 1972 (exhibition of licences);

- (f) under any provision of Part II of the Act or of any order or byelaw made thereunder, being a provision—
 - (i) as to the route to be followed by vehicles of the class to which that vehicle belongs; or
 - (ii) as to roads which are not to be used by such vehicles; or
 - (iii) as to the places where such vehicles may not turn so as to face in the opposite direction to that in which they were proceeding or as to the conditions under which such vehicles may so turn.
- (4) References in section 156(1) and (2) of the Act to a constable shall include references to a traffic warden only where he has reasonable cause to believe that there has been committed an offence in respect of a vehicle by its waiting, or being left or parked, or being loaded or unloaded, in a road.

Revocation

3. The Road Traffic (Functions of Traffic Wardens) Order (Northern Ireland) 1966(d) is hereby revoked.

SCHEDULE

Functions of traffic wardens

- 1.—(1) Traffic wardens may be employed to enforce the law with respect to an offence—
 - (a) under section 40 of the Act (failure to comply with requirements as to lighting of vehicles); or
 - (b) in respect of a vehicle by its waiting, or being left or parked, or being loaded or unloaded, in a road; or
 - (c) under section 12(4) of the Vehicles (Excise) Act (Northern Ireland) 1972 (exhibition of licences); or
 - (d) under section 98 of the Act (offences relating to parking places on roads where charges made);
 - (e) under any provision of Part II of the Act or of any order or byelaw made thereunder, being a provision—
 - (i) as to the route to be followed by vehicles of the class to which that vehicle belongs; or
 - (ii) as to roads which are not to be used by such vehicles; or
 - (iii) as to the places where such vehicles may not turn so as to face in the opposite direction to that in which they were proceeding or as to the conditions under which such vehicles may so turn.
- (2) For the purpose of the enforcement of the law with respect to such of the offences described in sub-paragraph (1) as are offences to which sections 171 to 177 of the Act (which relates to the fixed penalty procedure) apply, traffic wardens may exercise the functions conferred on constables by the said section in an area to which the said section extends.
- 2. Traffic wardens may be employed as parking attendants at parking places on roads.
- 3.—(1) Subject to the foregoing paragraphs, traffic wardens may be employed in the control and regulation of traffic (including pedestrians) or vehicles on roads or other public places and to discharge any other functions normally undertaken by the police in connection with the control and regulation of traffic (including pedestrians) or vehicles.
- (2) Nothing in this paragraph shall permit the functions described in sub-paragraph (1) to be exercised by a traffic warden who is in a moving vehicle.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order extends the functions of traffic wardens by authorising them to enforce the law in relation to—

- (1) the lights and reflectors required by law on moving vehicles;
- (2) the non-display of a vehicle excise licence;
- (3) travelling the wrong way or making a U turn in one-way streets;
- (4) the prohibition on the use of streets by certain vehicles;
- (5) the general control and regulation of traffic and contravention of traffic signs;
 - (6) the furnishing of names and addresses in certain cases.
