TERMS AND CONDITIONS OF EMPLOYMENT

The Redundancy Payments (Local Government etc.) (Modification) (Amendment) Order (Northern Ireland) 1987

30th January 1987 Made 25th March 1987 Coming into operation

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

The Department of Economic Development(a) in exercise of the powers conferred by section 26(5)(a) and (6) of the Contracts of Employment and Redundancy Payments Act (Northern Ireland) 1965(b) and now vested in it(c) and of every other power enabling it, in that behalf, hereby makes the following Order:

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Redundancy Payments (Local Government etc.) (Modification) (Amendment) Order (Northern Ireland) 1987 and shall come into operation on 25th March 1987.
 - (2) In this Order—
 - "principal Order" means the Redundancy Payments (Local Government etc.) (Modification) Order (Northern Ireland) 1986(d).

Amendments to the principal Order

- 2. The principal Order shall be amended as follows—
- (a) In Article 1(2) in the definition of "relevant event" after "the Act" there shall be added "or, in relation to any person to whom this Order applies by reason of an amendment contained in the Redundancy Payments (Local Government etc.) (Modification) (Amendment) Order (Northern Ireland) 1987, any event occurring on or after the coming into operation of that Order on the happening of which an employee may become entitled to a redundancy payment in accordance with the provisions of the Act.";
- (b) In Article 4(3) at the beginning there shall be inserted "subject to paragraph (4)'';
- (c) In Article 4 at the end there shall be added—
- "(4) Where a period of employment of a person to whom this Order applies by reason of an amendment contained in the Redundancy.

Payments (Local Government etc.) (Modification) (Amendment) Order (Northern Ireland) 1987 falls to be computed in accordance with the provisions of the Act as modified by this Order, the provisions of this Order shall have effect in relation to any period whether falling wholly or partly before or after the coming into operation of that Order.";

- (d) In Schedule 1 after entry 23 there shall be added—
 - "24. The Livestock Marketing Commission for Northern Ireland.
 - 25. The Agricultural Research Institute of Northern Ireland.
 - 26. The Fisheries Conservancy Board for Northern Ireland.
 - 27. The General Consumer Council for Northern Ireland.
 - 28. The Northern Ireland Tourist Board.
 - 29. The Labour Relations Agency.
 - 30. The Fair Employment Agency for Northern Ireland.
 - 31. The Equal Opportunities Commission for Northern Ireland.
 - 32. The Lisnevin Board of Management.
 - 33. The Rathgael and Whiteabbey Schools Management Board.
 - 34. The Police Authority for Northern Ireland.
 - 35. The Police Complaints Board for Northern Ireland."

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order, which comes into operation on 25th March 1987 amends the Redundancy Payments (Local Government etc.) (Modification) Order (Northern Ireland) 1986 ("the 1986 Order"). The 1986 Order modified certain redundancy payments provisions of the Contracts of Employment and Redundancy Payments Act (Northern Ireland) 1965 in their application to persons employed in relevant local government service so that their employment in the service is to be treated as if it was continuous for the purposes of those provisions. This Order adds to the list of employers to whose employees the 1986 Order applies.
