## **HOUSING; RATES**

# The Housing Benefit (General) (Amendment No. 3) Regulations (Northern Ireland) 1989

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 21(8) and (12)(g) of the Social Security (Northern Ireland) Order 1986(a) and of all other powers enabling it in that behalf, and with the consent of the Department of the Environment(b) so far as relates to matters with regard to which such consent is required, hereby makes the following regulations:

#### Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the Housing Benefit (General) (Amendment No. 3) Regulations (Northern Ireland) 1989 and shall come into operation on 16th October 1989.
- (2) In these regulations "the principal regulations" means the Housing Benefit (General) Regulations (Northern Ireland) 1987(c).

# Amendment of regulation 5 of the principal regulations

**2.** In regulation 5(9) of the principal regulations (circumstances in which a person is or is not to be treated as occupying a dwelling as his home) in the definition of "residential accommodation" at the end of paragraph (a) there shall be added "where board is available to the claimant".

# Amendment of regulation 8 of the principal regulations

3. In regulation 8(2)(b)(i) of the principal regulations (eligible housing costs) after "Order 1972" there shall be inserted "where board is available to the claimant".

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations.)

These regulations further amend the Housing Benefit (General) Regulations (Northern Ireland) 1987. They extend the housing costs for which housing benefit may be payable to include payments in respect of accommodation provided under Article 15 or 36 of the Health and Personal Social Services (Northern Ireland) Order 1972 where board is not available to the claimant (regulations 2 and 3).

The regulations correspond to provision contained in regulations made by the Secretary of State for Social Security in relation to Great Britain and accordingly, by virtue of section 10(2) of, and paragraph 21 of Schedule 3 to, the Social Security Act 1980 (c. 30), are not subject to the requirement of section 10(1) of that Act for prior reference to the Social Security Advisory Committee.
