**Foyle Area (Licensing of Fishing Engines)  
(Amendment No. 2) Regulations 1989**

*Made* . . . . . 1st December 1989

*Coming into operation* . . . . . 1st January 1990

The Foyle Fisheries Commission in exercise of its powers under section 13 of the Foyle Fisheries Act 1952(a) and section 13 of the Foyle Fisheries Act (Northern Ireland) 1952(b), with the approval of the Minister for the Marine in the Republic of Ireland(c) and the Department of Agriculture for Northern Ireland(d), hereby makes the following Regulations:—

*Citation and commencement*

1. These Regulations may be cited as the Foyle Area (Licensing of Fishing Engines) (Amendment No. 2) Regulations 1989 and shall come into operation on 1st January 1990.

*Amendment to the Foyle Area (Licensing of Fishing Engines) Regulations 1976*

2. Regulation 4(1) of the Foyle Area (Licensing of Fishing Engines) Regulations 1976(e) shall be amended as follows:—

- (i) delete “and” between sub-paragraphs (ii) and (iii); and
- (ii) after sub-paragraph (iii) add the following:

“(iv) (a) shall include details of the applicant’s receipts (whether in the form of wages or sale of fish) from fishing either as a licensee or as a senior helper or crew member for the holder or holders of draft or drift net licences, in each of the 3 years prior to the year in respect of which the application is made;

- (b) shall include details of the total income of the applicant and his spouse from salary, wages and profit from any trade or business as computed for the purpose of taxation along with any unemployment or other state benefits in each of the 3 years prior to the year in respect of which application is made.”

#### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations further amend the Foyle Area (Licensing of Fishing Engines) Regulations 1976 by making it a requirement for an applicant for a licence in respect of a drift net or a draft net to provide details of his receipts from such fishing in the previous 3 years and of the applicant's and his spouse's total income in the previous 3 years.
