The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by sections 104(5)(a), 115(1) and 154A(1) of, and paragraph 2 of Schedule 13 to, the Social Security (Northern Ireland) Act 1975(a) and Articles 52(1)(a) to (e) and (q) and 55 of, and paragraph 6(a) of Schedule 4 to, the Social Security (Northern Ireland) Order $1986(\mathbf{b})$ and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Social Security (Miscellaneous Provisions) (Amendment) Regulations (Northern Ireland) 1991 and shall come into operation on 1st November 1991.

(2) The Interpretation Act (Northern Ireland) 1954(c) shall apply to these regulations as it applies to a Measure of the Northern Ireland Assembly.

Amendment of the Social Security (Medical Evidence) Regulations (Northern Ireland) 1976

2.—(1) Schedule 2 to the Social Security (Medical Evidence) Regulations (Northern Ireland) 1976(d) shall be amended in accordance with paragraphs (2) and (3).

- (2) In Part I (rules), in paragraph 4---
- (a) in sub-paragraph (b) the words "where this is later than the actual confinement" shall be omitted; and

(b) in sub-paragraph (e) for "registered midwife either her registered number or address" there shall be substituted "registered midwife the personal identification number given to her by the United Kingdom Central Council for Nursing, Midwifery and Health Visiting ("UKCC") on her registration in Part 10 of the register maintained under section 10 of the Nurses, Midwives and Health Visitors Act 1979(a) and the expiry date of that registration".

(3) For Part II (form of maternity certificate) there shall be substituted the Part set out in Schedule 1 to these regulations.

Amendment of the Statutory Maternity Pay (General) Regulations (Northern Ireland) 1987

3. In regulation 32 of the Statutory Maternity Pay (General) Regulations (Northern Ireland) 1987(b) (penalties) after "25," there shall be inserted "25A,".

Amendment of the Social Security (Adjudication) Regulations (Northern Ireland) 1987

4.--(1) The Social Security (Adjudication) Regulations (Northern Ireland) 1987(c) shall be amended in accordance with paragraphs (2) to (4).

(2) In regulation 69 (review in income support cases) after paragraph (4) there shall be added the following paragraphs-

"(5) Where a claimant in receipt of income support, other than a claimant to whom Part II of Schedule 4 to the Income Support (General) Regulations (Northern Ireland) 1987(d) applies, lives in a nursing home or home for persons in need and is absent from the home for a period of less than one week, that absence shall not be treated as a relevant change of circumstances for the purposes of section 104(1)(b) and (bb) of the 1975 Act(e).

(6) In paragraph (5) "nursing home" and "home for persons in need" have the same meanings as they have in regulation 19 of the Income Support (General) Regulations (Northern Ireland) 1987(f).".

(3) After regulation 69 there shall be inserted the following regulation—

"Repayment of student loan not a change of circumstances for income support

69A. The repayment of a loan to which regulation 66A of the Income Support (General) Regulations (Northern Ireland) 1987(g) (treatment of student loans) applies shall not be treated as a relevant change of circumstances for the purposes of section 104(1)(b) and (bb) of the 1975 Act.".

(4) After regulation 70 (review in family credit cases) there shall be inserted the following regulation—

"Repayment of student loan not a change of circumstances for family credit

70A. The repayment of a loan to which regulation 42A of the Family Credit (General) Regulations (Northern Ireland) 1987(**a**) (treatment of student loans) applies shall not be treated as a relevant change of circumstances for the purposes of section 104(1)(b) and (bb) of the 1975 Act.".

Amendment of the Statutory Maternity Pay (Medical Evidence) Regulations (Northern Ireland) 1987

5.—(1) The Schedule to the Statutory Maternity Pay (Medical Evidence) Regulations (Northern Ireland) 1987(b) shall be amended in accordance with paragraphs (2) and (3).

(2) In Part I (rules), in paragraph 4—

- (a) in sub-paragraph (b) the words "where this is later than the actual confinement" shall be omitted; and
- (b) in sub-paragraph (e) for "registered midwife either her registered number or address" there shall be substituted "registered midwife the personal identification number given to her by the United Kingdom Central Council for Nursing, Midwifery and Health Visiting ("UKCC") on her registration in Part 10 of the register maintained under section 10 of the Nurses, Midwives and Health Visitors Act 1979 and the expiry date of that registration".

(3) For Part II (form of maternity certificate) there shall be substituted the Part set out in Schedule 2 to these regulations.

Amendment of the Social Security (Claims and Payments) Regulations (Northern Ireland) 1987

6.—(1) The Social Security (Claims and Payments) Regulations (Northern Ireland) 1987(c) shall be amended in accordance with paragraphs (2) to (7).

(2) In regulation 2(1) (interpretation) the definition of "period of cold weather" shall be omitted.

(3) In regulation 6(3) (date of claim) the words "or expenses for heating, which appear to the Department to have been or to be likely to be incurred in cold weather" shall be omitted.

- (4) In regulation 13 (advance claims and awards)—
- (a) in paragraph (3) at the beginning there shall be inserted "Subject to paragraph (4),"; and

(b) after paragraph (3) there shall be added the following paragraphs— (4) Paragraphs (1) and (2) shall apply to a claim for family credit

made____

- (a) on or after 10th March 1992 and before 7th April 1992;
- (b) in respect of a period beginning on or after 7th April 1992; and
- (c) by a person who, or, if he is a member of a married or unmarried couple, he or the other member of the couple, is engaged and normally engaged in remunerative work for not less than 16 but less than 24 hours a week on the date the claim is made.

(5) In paragraph (4)(c) "remunerative work" and "engaged and normally engaged in remunerative work" shall be construed in accordance with regulations 4 and 5 respectively of the Family Credit (General) Regulations (Northern Ireland) 1987(**a**).".

(5) In regulation 19(4) (time for claiming benefit) the words "or expenses for heating, which appear to the Department to have been or to be likely to be incurred in cold weather," shall be omitted.

(6) In Schedule 4 (prescribed times for claiming benefit) in column (2) opposite paragraph 7 after sub-paragraph (b) there shall be added the following sub-paragraph—

"(c) where a claim for family credit is treated as if made for a period beginning with the relevant day by virtue of regulation 13, the period beginning on 10th March 1992 and ending on 6th April 1992.".

(7) In Schedule 8A (deductions from benefit and direct payment to third parties)—

(a) in paragraph 1 (interpretation)—

- (i) for the definition of "5 per cent. of the personal allowance for a single claimant aged not less than 25 years" and "10 per cent. of the personal allowance for a single claimant aged not less than 25 years" there shall be substituted the following definition—
 - " "5 per cent. of the personal allowance for a single claimant aged not less than 25 years" means where the percentage is not a multiple of 5 pence the sum obtained by rounding that 5 per cent. to the next higher such multiple;",
- (ii) after the definition of "5 per cent. of the personal allowance for a single claimant aged not less than 25 years" there shall be inserted the following definition—
 - " "hostel" means an establishment other than a home for persons in need or nursing home within the meaning of regulation

19(2) of the Income Support Regulations(a) or residential accommodation within the meaning of regulation 21(3) of those regulations(b)-

- (a) in which there is provided for persons generally, or for a class of persons, accommodation, otherwise than in separate and self-contained premises, and either board or facilities of a kind set out in paragraph 4A(1)(d)adequate to the needs of those persons; and—
- (b) which is—
 - (i) managed by or owned by a housing association registered with the Department of the Environment: in accordance with Article 124 of the Housing (Northern Ireland) Order 1981(c),
 - (ii) operated other than on a commercial basis and in respect of which funds are provided wholly or in part by a government department or public body, or
 - (iii) managed by a voluntary organisation or charity and provides care, support or supervision with a view to assisting those persons to be rehabilitated or resettled within the community;
- (c) in head (iii) "voluntary organisation" means any association carrying on any activities otherwise than for the purpose of gain by the association or by individual members thereof, but shall not include any public body;",
- (iii) in the definition of "housing costs" after "1(*a*)," there shall be inserted "(*aa*)," and after "Regulations" there shall be added "and payments analogous to those specified in this definition",
- (iv) in the definition of "mortgage payment" for "interest on a mortgage" there shall be substituted "interest on a loan whether or not secured by way of a mortgage", and
- (v) in the definition of "personal allowance for a single claimant aged not less than 25 years' for "paragraph 1(1)(c)" there shall be substituted "paragraph 1(1)(e)";
- (b) in paragraph 2(1) (general) after head (b) there shall be inserted the following head-

"(bb) hostel payments;";

- (c) in paragraph 4(3)(a) (miscellaneous accommodation costs) for "divided by the number of days in the part-week" there shall be substituted "divided by 7 and multiplied by the number of days in the part-week";
- (d) after paragraph 4 there shall be inserted the following paragraph—

"Hostel payments

4A.—(1) This paragraph applies to a beneficiary if—

- (a) he has been awarded income support;
- (b) he or his partner has claimed housing benefit;
- (c) he or his partner is resident in a hostel; and
- (d) the charge for that hostel includes a payment, whether direct or indirect, for one or more of the following services—
 - (i) a service charge for fuel,
 - (ii) meals,
 - (iii) laundry,
 - (iv) cleaning (other than communal areas).

(2) Subject to sub-paragraph (3), where a beneficiary has been awarded specified benefit the adjudicating authority may determine that an amount of specified benefit shall be paid to the person or body to whom the charges referred to in sub-paragraph (1)(d) are or would be payable.

(3) The amount of any payment to a third party under this paragraph shall be either—

- (a) the aggregate of the amounts determined by the Northern Ireland Housing Executive in accordance with Schedule 1 to the Housing Benefit Regulations(a) (ineligible service charges) in respect of the charges referred to in sub-paragraph (1)(d); or
- (b) if no amount has been determined under head (a), an amount which the adjudicating authority estimates to be the amount which is likely to be so determined.

(4) Sub-paragraph (2) shall not apply to a deduction in respect of a service charge for fuel if that charge is one such as is mentioned in paragraph 5(5) of Schedule 1 to the Housing Benefit Regulations (variable service charges for fuel) unless the adjudicating authority is satisfied on the evidence available at the date of the determination that the amount of the charge does not normally alter more than twice in any one year.

(5) Where an award of income support is calculated in accordance with regulation 73(1) of the Income Support Regulations(b) the amount of any payment of income support to a third party determined under sub-paragraph (2) shall be an amount calculated in accordance with sub-paragraph (3)(a) or (b) divided by 7 and multiplied by the number of days in the part-week and no payment shall be made to a third party under this sub-paragraph where the Department certifies it would be impracticable to do so in that particular case.";

- (e) in paragraph 6 (fuel costs)—
 - (i) in sub-paragraph (2) for head (a) there shall be substituted the following head—
 - "(a) in respect of a debt to which sub-paragraph (1) applies a weekly amount equal to 5 per cent. of the personal allowance for a single claimant aged not less than 25 years, but where a debt remains outstanding in respect of more than one fuel item the aggregate of the amounts calculated under this head shall not exceed twice 5 per cent. of the personal allowance for a single claimant aged not less than 25 years;", and
 - (ii) sub-paragraph (3) shall be omitted; and
- (f) in paragraph 8(3) (aggregate amounts and maximum amount of payments to third parties) before "5(2)" in both places where it occurs there shall be inserted "3(2)(a),".

Amendment of the Social Security (Miscellaneous Provisions) (Amendment) Regulations (Northern Ireland) 1990

7. In regulation 9 of the Social Security (Miscellaneous Provisions) (Amendment) Regulations (Northern Ireland) 1990(a) for "(Amendment)" where it first occurs there shall be substituted "(Amendment No. 2)".

Revocations

8. The regulations specified in column (1) of Schedule 3 are revoked to the extent mentioned in column (3).

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations correspond to provision contained in regulations made by the Secretary of State for Social Security in relation to Great Britain and accordingly, by virtue of section 10(2) of, and paragraph 21 of Schedule 3 to, the Social Security Act 1980 (c. 30), are not subject to the requirement of section 10(1) of that Act for prior reference to the Social Security Advisory Committee.

In the Social Security (Medical Evidence) Regulations (Northern Ireland) 1976 and the Statutory Maternity Pay (Medical Evidence) Regulations (Northern Ireland) 1987—

- (a) the rules for the completion of maternity certificates are amended to provide that the expected week of confinement is completed in all cases and to reflect changes in the manner of registration of a midwife registered by the United Kingdom Central Council for Nursing, Midwifery and Health Visiting (regulations 2(2) and 5(2)); and
- (b) a new form of maternity certificate is prescribed (regulations 2(3) and 5(3) and Schedules 1 and 2).

Regulation 32 of the Statutory Maternity Pay (General) Regulations (Northern Ireland) 1987 is amended to include a reference to regulation 25A (regulation 3).

In the Social Security (Adjudication) Regulations (Northern Ireland) 1987-

- (a) regulation 69 is amended to provide that where a person who lives in a nursing home or home for persons in need is absent from it for less than a week that absence is not to be treated as a relevant change of circumstances for the purposes of reviewing his award of income support (regulation 4(2)); and
- (b) regulations 69A and 70A are inserted to provide that the repayment of a student loan is not to be treated as a relevant change of circumstances for the purposes of reviewing an award of income support or family credit respectively (regulation 4(3) and (4)).

In the Social Security (Claims and Payments) Regulations (Northern Ireland) 1987 ("the Claims and Payments Regulations")—

- (a) regulations 2(1), 6(3) and 19(4) are amended to omit provision relating to cold weather payments (regulations 6(2), (3) and (5));
- (b) regulation 13 is amended to permit advance claims to be made for family credit during the period from 10th March 1992 to 6th April 1992 in certain circumstances and paragraph 7 of Schedule 4 is amended by prescribing a time for claiming benefit where claims are made during that period (regulation 6(4) and (6)); and
- (c) Schedule 8A is amended to make provision for payment of certain hostel charges to third parties and to reduce the level of deductions from benefit for arrears of fuel costs (regulation 6(7)).

Regulation 8 revokes regulation 15A of, and paragraph 9A of Schedule 4 to, the Claims and Payments Regulations and also contains some consequential revocations.

A number of other amendments of a minor drafting nature are also made.
