Foyle Area (Close Season) Regulations 1993

The Foyle Fisheries Commission, in exercise of its powers under sections 13(1), 28(1) and 28(4) of the Foyle Fisheries Act $1952(\mathbf{a})$ and sections 13(1), 27(1) and 27(4) of the Foyle Fisheries Act (Northern Ireland) 1952(b) with the approval of the Minister for the Marine in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d) hereby makes the following Regulations:-

Citation and commencement

1. These Regulations may be cited as the Foyle Area (Close Season) Regulations 1993 and shall come into operation on 31st July 1993.

Close season

2. The Annual Close Season in the Foyle Area, with the exception of the River Roe, shall be the period beginning on 1st August and ending on 14th June next following (both dates inclusive).

3. The Annual Close Season in the River Roe shall be the period beginning on 15th August and ending on 30th June next following (both dates inclusive).

Revocation

4. The Foyle Area (Close Season) Regulations 1992(e) are hereby revoked.
