Curriculum (Programme of Study and Attainment Target in Technology and Design) Order (Northern Ireland) 1995

The Department of Education, in exercise of the powers conferred on it by Article 7(1)(a) and (5) of the Education Reform (Northern Ireland) Order 1989(a) and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Curriculum (Programme of Study and Attainment Target in Technology and Design) Order (Northern Ireland) 1995 and shall come into operation on 1st August 1995.

Application `

2. The provisions of this Order shall apply in respect of pupils in the first, second and third years of the third key stage.

Interpretation

3. In this Order—

"the Document" means the document published by Her Majesty's Stationery Office entitled "Technology and Design, Programmes of Study and Attainment Target" (b); and

references to levels of attainment are references to the levels set out in the Document in relation to the attainment target.

Specification of programme of study and attainment target

- **4.** It is hereby directed that the provisions relating to the programmes of study and the attainment target set out in the Document shall have effect as provided in Articles 5 to 7 for the purpose of specifying in relation to Technology and Design—
 - (a) a programme of study; and
 - (b) an attainment target.

- 5. The programme of study for key stage 3 in the Document (which relates to the attainment target referred to in Article 6) is specified in relation to that key stage as set out in the Document.
- **6.** The attainment target described in the Document is specified in relation to key stage 3 at levels 3 to 7.
- 7. The contents printed in italics in the Document (which serve to illustrate the programme of study and the attainment target described) do not form part of the provisions which have effect by virtue of this Order.

Revocation

8. The Curriculum (Programmes of Study and Attainment Target in Technology and Design) Order (Northern Ireland) 1993(a) is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order, made under Article 7(1) of the Education Reform (Northern Ireland) Order 1989 ("the 1989 Order") specifies a programme of study and attainment target in relation to technology and design.

Article 7(5) of the 1989 Order allows for an Order under Article 7(1), instead of containing the provisions to be made, to refer to provisions in a Document published by Her-Majesty's Stationery Office and to direct that these provisions shall have effect according to the Order.

This Order revokes and replaces the Curriculum (Programmes of Study and Attainment Target in Technology and Design) Order (Northern Ireland) 1993, but continues to provide for that subject at key stage 3 only.

This Order further provides that any contents printed in italics in the Document are for illustrative purposes only, and do not form part of the provisions which have effect by virtue of this Order.

This Order comes into operation on 1st August 1995.
