The Secretary of State in pursuance of section 13 of the Prison Act (Northern Ireland) 1953(a), as extended by section 2 of the Treatment of Offenders Act (Northern Ireland) 1968(b), hereby makes the following rules----

Citation and commencement

1. These rules may be cited as the Prison and Young Offenders Centre (Amendment) Rules (Northern Ireland) 1995 and shall come into operation on 1st August 1995.

Interpretation

2. In these rules any reference to the principal rules is a reference to the Prison and Young Offenders Centre Rules (Northern Ireland) 1995(c).

Inquiry into charge

3.—(1) In paragraph (3) of Rule 36 of the principal rules the words "pending further investigation" shall be omitted.

(2) Paragraph (5) of that Rule shall be omitted.

Disciplinary awards

4. In paragraph (2) of Rule 95 of the principal rules after the word "one" insert "or more" and in paragraph (4) substitute for the words "Rule 92" the words "Rule 94".

EXPLANATORY NOTE

(This note is not part of the Rules.)

These rules amend the Prison and Young Offenders Centre Rules (Northern Ireland) 1995 (the principal rules).

Rule 3 amends Rule 36 of the principal rules to extend the circumstances in which a governor may adjourn a disciplinary adjudication.

Rule 4 amends Rule 95 of the principal rules. The inclusion of the phrase "or more" enables a governor to award more than one punishment where a young offender has committed a disciplinary offence. The rule also replaces the incorrect reference to Rule 92 in the principal rules.

Rule 5 repeals the Prison Rules (Northern Ireland) 1983 and the Young Offenders Centre Rules (Northern Ireland) 1983 which were not repealed by the principal rules.
