The Sheep Annual Premium (Amendment) Regulations (Northern Ireland) 1995

Made 23rd October 1995 . 15th November 1995 Coming into operation

The Department of Agriculture being a Department designated(a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the European Community, in exercise of the powers conferred on it by the said section 2(2) and of every other power enabling it in that behalf, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as The Sheep Annual Premium (Amendment) Regulations (Northern Ireland) 1995 and shall come into operation on 15th November 1995.

Interpretation

- 2.—(1) In these Regulations, "the principal Regulations" means The Sheep Annual Premium Regulations (Northern Ireland) 1992(c), and
- (2) The Interpretation Act (Northern Ireland) 1954(d) shall apply to these Regulations as it applies to a Measure of the Northern Ireland Assembly.

Amendment

- 3. The following paragraph shall be substituted for paragraph 2 of regulation 3 (application for a premium) of the principal Regulations—
 - "(2) A producer who applies for a premium in respect of a given marketing year shall deliver his application to the competent authority—
 - (a) on or after the 13th December in the preceding calendar year; and
 - (b) not later than 9th January in that marketing year (both dates inclusive) or if 9th January is a Saturday, Sunday or public holiday the next following working day."

EXPLANATORY NOTE

(This note is not part of the Reglations.)

These Regulations amend the Sheep Annual Premium Regulations (Northern Ireland) 1992 by substituting a single application period instead of the two original application periods.

These Regulations provide that a producer making an application for sheep annual premium in respect of a particular marketing year as defined by Article 3(3) of Council Regulation (EEC) No. 3013/89 (O.J. No. L289, 7.10.89, p. 1) shall deliver his application on or after 13th December in the preceding calendar year and not later than 9th January in the marketing year concerned.
