SOCIAL SECURITY

The Social Security (Incapacity for Work and Severe Disablement Allowance) (Amendment) Regulations (Northern Ireland) 1997

> Made - - - - 21st March 1997 Coming into operation 1st April 1997

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by sections 68(11)(cc), 167D(1) and 171 of the Social Security Contributions and Benefits (Northern Ireland) Act 1992(1) and of all other powers enabling it in that behalf, hereby makes the following Regulations:

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Social Security (Incapacity for Work and Severe Disablement Allowance) (Amendment) Regulations (Northern Ireland) 1997 and shall come into operation on 1st April 1997.
- (2) The Interpretation Act (Northern Ireland) 1954(2) shall apply to these Regulations as it applies to a Measure of the Assembly.

Amendment of the Social Security (Severe Disablement Allowance) Regulations

- **2.** In regulation 10(1) of the Social Security (Severe Disablement Allowance) Regulations (Northern Ireland) 1984(**3**) (adjudication)—
 - (a) sub-paragraph (a) shall be omitted;
 - (b) for sub-paragraph (b) there shall be substituted the following sub-paragraph—
 - "(b) evidence that on that day he is or was entitled to the highest rate of the care component of disability living allowance prescribed in accordance with section 72(3) and (4)(a) of the Contributions and Benefits Act;";
 - (c) for sub-paragraph (f) there shall be substituted the following sub-paragraph—

"(f) evidence that on that day he is or was certified as blind and in consequence is registered as blind in a register maintained by, or on behalf of, a Health and Social Services Board established under Article 16 of the Health and Personal Social Services (Northern Ireland) Order 1972(4);".

Amendment of the Social Security (Incapacity for Work) (General) Regulations

- **3.** In regulation 10(2) of the Social Security (Incapacity for Work) (General) Regulations (Northern Ireland) 1995(**5**) (certain persons with a severe condition to be treated as incapable of work) after sub-paragraph (a) there shall be inserted the following sub-paragraphs—
 - "(aa) that he is entitled to—
 - (i) a disablement pension by virtue of section 103 of the Contributions and Benefits Act by reference to a degree of disability of not less than 80 per cent.;
 - (ii) a disablement pension by virtue of Part III of the Naval, Military and Air Forces etc. (Disablement and Death) Service Pensions Order 1983(6) or of Part III of the Personal Injuries (Civilians) Scheme 1983(7) by reference to a degree of disability of not less than 80 per cent.;
 - (ab) that evidence in accordance with regulation 10 of the Social Security (Severe Disablement Allowance) Regulations (Northern Ireland) 1984(8) (adjudication), establishes that he suffers from a loss of physical or mental faculty such that the extent of the resulting disablement amounts to not less than 80 per cent."

Saving

- **4.**—(1) Where—
 - (a) before the coming into operation of these Regulations, a person is entitled to severe disablement allowance by virtue of having satisfied regulation 10(1)(a), (b) or (f) of the Severe Disablement Allowance Regulations, as then in operation; and
 - (b) after the coming into operation of these Regulations, he is a person in respect of whom any day is to be treated as part of one period of incapacity for work, within the meaning of section 30C(1) of the Social Security Contributions and Benefits (Northern Ireland) Act 1992(9), which began before the coming into operation of these Regulations,

regulation 10 of the Severe Disablement Allowance Regulations shall continue to have effect as if regulation 2 had not been made.

(2) In this regulation "the Severe Disablement Allowance Regulations" means the Social Security (Severe Disablement Allowance) Regulations (Northern Ireland) 1984.

Revocation

5. Regulation 8 of the Disability Living Allowance and Disability Working Allowance (Consequential Provisions) Regulations (Northern Ireland) 1992(**10**) is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations further amend the Social Security (Severe Disablement Allowance) Regulations (Northern Ireland) 1984 ("the Severe Disablement Allowance Regulations") and the Social Security (Incapacity for Work) (General) Regulations (Northern Ireland) 1995 ("the General Regulations").

The Severe Disablement Allowance Regulations are amended so that the partially sighted and those entitled to attendance allowance, the mobility component or the middle rate of the care component of disability living allowance and war pensions mobility supplement are not automatically treated as meeting the 80 per cent. disablement test (regulation 2).

The General Regulations are amended to make provision so that certain persons who are entitled to disablement pension, or assessed for the purpose of severe disablement allowance as 80 per cent. disabled, are treated as incapable of work (regulation 3).

The Regulations also make a saving provision for the protection of those in receipt of severe disablement allowance before the coming into operation of these Regulations (regulation 4) and a consequential revocation (regulation 5).

These Regulations correspond to provision contained in Regulations made by the Secretary of State for Social Security in relation to Great Britain and accordingly, by virtue of section 149(3) of, and paragraph 10 of Schedule 5 to, the Social Security Administration (Northern Ireland) Act 1992 (c. 8), are not subject to the requirement of section 149(2) of that Act for prior reference to the Social Security Advisory Committee.
