MAGISTRATES' COURTS

The Magistrates' Courts Fees (Amendment) Order (Northern Ireland) 1997

Made - - - - 19th March 1997 Coming into operation 1st April 1997

The Lord Chancellor, in exercise of the powers conferred on him by section 116(1) of the Judicature (Northern Ireland) Act 1978(1), after consultation with the Lord Chief Justice and with the concurrence of the Treasury, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Magistrates' Courts Fees (Amendment) Order (Northern Ireland) 1997 and shall come into operation on 1st April 1997.

Interpretation

- **2.** In this Order, "the 1996 Order" means the Magistrates' Courts Fees Order (Northern Ireland) 1996(2).
- **3.** For Section D in Schedule 1 to the 1996 Order there shall be substituted the new Section D set out in Schedule 1 to this Order.
- **4.** In Section E in Schedule 1 to the 1996 Order after fee No. 24 there shall be inserted the following new fee:—
 - "24A. Application for temporary continuance of business in other premises under Article 26£30·00"
- **5.** For Section F in Schedule 1 to the 1996 Order there shall be substituted the new Section F set out in Schedule 2 to this Order.
- **6.** In Section G in Schedule 1 to the 1996 Order for the amount of £10·00, payable in respect of Fee No. 52, there shall be substituted the amount of £12·00.
