## **AGRICULTURE**

Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 1999

Made - - - - 19th April 1999 Coming into operation 17th May 1999

The Department of Agriculture, in exercise of its powers conferred on it by section 1(1) of the Seeds Act (Northern Ireland) 1965(2) and of all powers enabling it in that behalf, after consultation with representatives of such interests as appear to it to be concerned, hereby makes the following Regulations:

### Citation, commencement and interpretation

- **1.**—(1) These Regulations may be cited as the Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 1999 and shall come into operation on 17th May 1999.
  - (2) In these Regulations, "the Department" means the Department of Agriculture.

## Fees

**2.** Every person who makes an application to the Department for the certification of seed potato crops under regulation 5(1) of the Seed Potatoes Regulations (Northern Ireland) 1981(3) shall forward with that application the appropriate fee in accordance with the Schedule.

#### Revocation

**3.** The Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 1995(4) are hereby revoked.

SCHEDULE Regulation 2

## Fees for the certification of seed potato crops

## Applications Fee

- 1. In the case of an application received by £32.00 the Department on or before 30th May in any calendar year—
  - (a) where the total area of the crop does not exceed 1 hectare
  - (b) (b) where the total area of the crop £16.00 per half hectare or part of a half hectare exceeds 1 hectare
- 2. In the case of an application received by £48.00 the Department after 30th May in any calendar year—
  - (a) where the total area of the crop does not exceed 1 hectare
  - (b) (b) where the total area of the crop £24.00 per half hectare or part of a half hectare exceeds 1 hectare

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations.)

These Regulations increase the fees payable to the Department of Agriculture in respect of the certification of seed potato crops arising under the Seed Potatoes Regulations (Northern Ireland) 1981 (regulation 2 and the Schedule).

In the case of an application received by the Department on or before 30th May in any calendar year:—

- (a) where the total area of the crop does not exceed 1 hectare the fee is increased from £29.00 to £32.00;
- (b) where the total area of the crop exceeds 1 hectare the fee is increased from £14.50 to £16.00 per half hectare or part of a half hectare.

In the case of an application received by the Department after 30th May in any calendar year:—

- (a) where the total area of the crop does not exceed 1 hectare the fee is increased from £43.50 to £48.00;
- (b) where the total area of the crop exceeds 1 hectare the fee is increased from £21.75 to £24.00 per half hectare or part of a half hectare.

The Regulations also revoke the Seed Potatoes (Crop Fees) Regulations (Northern Ireland) 1995 (regulation 3).
