Coming into operation 14th June 1999

The Lord Chancellor, in exercise of the powers conferred by Article 36(3) of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981(1) and now vested in him(2), and after consultation with the Lord Chief Justice, the Attorney General, the Crown Court Rules Committee, the County Court Rules Committee and the Magistrates' Courts Rules Committee and with the approval of the Treasury, hereby makes the following Rules:—

Citation and commencement

1. These Rules may be cited as the Legal Aid in Criminal Cases (Statement of Means) Rules (Northern Ireland) 1999 and shall come into operation on 14th June 1999.

Revocation

2. The Legal Aid in Criminal Cases (Statement of Means) Rules (Northern Ireland) 1988(3) are hereby revoked.

Statement of means form

3. The form set out in the Schedule shall be the prescribed form for the purposes of Article 32(1) of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981 (statement of means for the purposes of legal aid in criminal proceedings).
