**Foyle Area (Licensing of Fishing Engines) (Amendment No. 2)
Regulations 1999**

Made 26th November 1999

Coming into operation 1st January 2000

The Foyle Fisheries Commission in exercise of its powers under section 13(1) and (2) of the Foyle Fisheries Act 1952(a), and section 13(1) and (2) of the Foyle Fisheries Act (Northern Ireland) 1952(b), with the approval of the Minister for the Marine and Natural Resources in the Republic of Ireland(c) and the Department of Agriculture for Northern Ireland(d), hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Foyle Area (Licensing of Fishing Engines) (Amendment No. 2) Regulations 1999 and shall come into operation on 1st January 2000.

Amendment to the Foyle Area (Licensing of Fishing Engines) Regulations 1976

2. There shall be substituted for the Schedule to the Foyle Area (Licensing of Fishing Engines) Regulations 1976(e), the following Schedule:—
