Citation and interpretation

- **1.**—(1) This Order may be cited as the Social Security (1998 Order) (Commencement No. 3) Order (Northern Ireland) 1999.
 - (2) In this Order "the Order" means the Social Security (Northern Ireland) Order 1998.

Appointed days

- 2. The day appointed for the coming into operation of—
 - (a) Article 48 of the Order (Class 1 contributions)—
 - (i) for the purpose only of authorising the making of regulations is 24th February 1999, and
 - (ii) for all other purposes, is 6th April 1999; and
 - (b) the provisions of the Order specified in the Schedule is 6th April 1999.
