**The Equality (Disability, etc.) (2000 Order) (Commencement
No. 1) Order (Northern Ireland) 2000**

Made *21st April 2000*

The Office of the First Minister and deputy First Minister, in exercise of the powers conferred on it by Article 1(2) of the Equality (Disability, etc.) (Northern Ireland) Order 2000^(a) and of all other powers enabling it in that behalf, hereby makes the following Order:

Citation and interpretation

1.—(1) This Order may be cited as the Equality (Disability, etc.) (2000 Order) (Commencement No. 1) Order (Northern Ireland) 2000.

(2) In this Order—

“the 1995 Act” means the Disability Discrimination Act 1995^(b); and

“the 2000 Order” means the Equality (Disability, etc.) (Northern Ireland) Order 2000.

2. The day appointed for the coming into operation of the provisions of Part II of the 2000 Order specified in column 1 of the Schedule to this Order (which relate to the matters mentioned in column 2 of that Schedule) is 25th April 2000.
