The Education (Student Support) (Amendment) Regulations (Northern Ireland) 2003

The Department for Employment and Learning(1), in exercise of the powers conferred by Articles 3 and 8(4) of the Education (Student Support) (Northern Ireland) Order 1998(2) and now vested in it(3) and of every other power enabling it in that behalf, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Education (Student Support) (Amendment) Regulations (Northern Ireland) 2003 and shall come into operation on 4th April 2003.

2. The Education (Student Support) Regulations (Northern Ireland) 2002(4) shall be amended in accordance with these Regulations.

Amendments to the Regulations

- 3.—(1) Regulation 12 shall be amended as follows.
- (2) For paragraph (3)(e)(ii) substitute –
- "(ii) a Health Authority or a Strategic Health Authority established pursuant to section 8 of the National Health Service Act 1977(5) or a Special Health Authority established pursuant to section 11 of that Act (6);"
