# The Education (Student Support) (Amendment) Regulations (Northern Ireland) 2003

Made -	-	-	-	-	3rd March 2003
Coming into operation				4th April 2003	

The Department for Employment and Learning( $\mathbf{a}$ ), in exercise of the powers conferred by Articles 3 and 8(4) of the Education (Student Support) (Northern Ireland) Order 1998( $\mathbf{b}$ ) and now vested in it( $\mathbf{c}$ ) and of every other power enabling it in that behalf, hereby makes the following Regulations:

#### **Citation and commencement**

**1.** These Regulations may be cited as the Education (Student Support) (Amendment) Regulations (Northern Ireland) 2003 and shall come into operation on 4th April 2003.

**2.** The Education (Student Support) Regulations (Northern Ireland) 2002(**d**) shall be amended in accordance with these Regulations.

#### Amendments to the Regulations

**3.**—(1) Regulation 12 shall be amended as follows.

- (2) For paragraph (3)(e)(ii) substitute -
  - "(ii) a Health Authority or a Strategic Health Authority established pursuant to section 8 of the National Health Service Act 1977(e) or a Special Health Authority established pursuant to section 11 of that Act (f);"

**4.** In regulation 21(14) for the words "regulation 12(2)(a) and (b)" substitute "regulation 12(2)(a) or (b)".
