**Bangor (Harbour Area) Order (Northern Ireland) 2003**

*Made* - - - - - *24th April 2003*

*Coming into operation* *2nd June 2003*

The Department for Regional Development<sup>(a)</sup>, in exercise of the powers conferred by section 10(2) of the Harbours Act (Northern Ireland) 1970<sup>(b)</sup> and now vested in it<sup>(c)</sup> and of every other power enabling it in that behalf, having received an application from North Down Borough Council, hereby makes the following Order:

**Citation and commencement**

1. This Order may be cited as the Bangor (Harbour Area) Order (Northern Ireland) 2003 and shall come into operation on 2nd June 2003.

**Harbour area**

2.—(1) The area at Bangor Harbour within which North Down Borough Council and its officers may exercise their powers shall be that area shown enclosed by a continuous red line on the map and the area within which any dues for the time being leviable may be charged shall be that area within the Harbour shown shaded yellow on the map.

(2) In this Article “the map” means the map marked “Bangor (Harbour Area) Order (Northern Ireland) 2003” which has been signed and sealed with reference to this Order and deposited at the office of the Department for Regional Development, Clarence Court, 10-18 Adelaide Street, Belfast, BT2 8GB.
