The Secretary of State, in accordance with the requirements of section 25 and 26 of the Police (Northern Ireland) Act 1998<sup>(a)</sup> hereby makes the following amendment to the regulations:

**PART I  
GENERAL**

**Citation and commencement**

**1.** These regulations may be cited as the Police Service of Northern Ireland (Appeals) (Amendment) Regulations 2003 and shall come into operation on 4th November 2003.

**2.** The Royal Ulster Constabulary (Appeals) Regulations 2000<sup>(b)</sup> shall be amended as follows:

In regulation 8(1)(a) of the Royal Ulster Constabulary (Appeals) Regulations 2000, delete the words “one” to the end and substitute the following wording: “one shall be a person chosen from a list of persons who are either (a) members of the Bar of Northern Ireland of at least seven years’ standing; or (b) solicitors of the Supreme Court of at least seven years’ standing and have been nominated by the Lord Chief Justice for the purposes of this regulation”.

## PART II SUPPLEMENTAL

**3.** The Police Service of Northern Ireland (Conduct) Regulations 2003<sup>(a)</sup> shall be amended as follows:

In the Schedule to the Regulations under Article 9, *Fitness for Duty*, paragraph 9.2, between the words “officers” and “shall” insert the words “on duty”.
