**The Industrial Tribunals (Constitution and Rules  
of Procedure) Regulations (Northern Ireland) 2005**

*Made* - - - - *22nd March 2005*

*Coming into operation* *3rd April 2005*

The Department for Employment and Learning<sup>(1)</sup>, in exercise of the powers conferred on it by Article 26(1) of the Health and Safety at Work (Northern Ireland) Order 1978<sup>(2)</sup>, Articles 3(1), 6(6)<sup>(3)</sup> and (6A)<sup>(4)</sup>, 9(1), (2), (3)<sup>(5)</sup>, (3ZA)<sup>(6)</sup>, (3A)<sup>(7)</sup> and (5), 9A(1) and (2)<sup>(8)</sup>, 11(1)<sup>(9)</sup>, (2) and (4), 12(2), (5), (6) and (7), 12A(1)<sup>(10)</sup>, 13(1), 14(2), 15(1), (1A), (1B), (1C)<sup>(11)</sup> and (2), 15A<sup>(12)</sup>, 21<sup>(13)</sup> and 25(5) of the Industrial Tribunals (Northern Ireland) Order 1996<sup>(14)</sup>, and now vested in it<sup>(15)</sup>, and of all other powers enabling it in that behalf, hereby makes the following Regulations:
