The Department of Agriculture and Rural Development(\mathbf{a}) in exercise of the powers conferred on it by sections $2(\mathbf{b})$, $3(1)(\mathbf{c})$, $3B(\mathbf{d})$, and $4(1)(\mathbf{e})$ of the Plant Health Act (Northern Ireland) 1967(\mathbf{f}), and of all other powers enabling it in that behalf, makes the following Order:

Citation and commencement

1. This Order may be cited as the Plant Health (*Phytophthora ramorum*) (Amendment) Order (Northern Ireland) 2005 and shall come into operation on 10th June 2005.

Amendment of the Plant Health (Phytophthora ramorum) Order (Northern Ireland) 2005

- **2.**—(1) The Plant Health (*Phytophthora ramorum*) Order (Northern Ireland) 2005(**g**) shall be amended in accordance with paragraphs (2) and (3).
- (2) In Article 13(2) for the words "Subject to paragraph (3) an" there shall be substituted the word "An".
- (3) In Article 15(1)(a) for the words "Articles 3 or 5" there shall be substituted "Articles 3, 5, 6, 7(1) or (3)".
