An agreement in force under Article 40 of the Planning (Northern Ireland) Order 1991(**b**) immediately before Article 23 of the Planning (Amendment) (Northern Ireland) Order 2003 comes into operation has effect from that date as if it were an agreement entered into under that Article 40 as substituted by that Article 23.
