Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 2005

Made - - - - - 5th August 2005

Coming into operation 1st September 2005

The Department of Agriculture and Rural Development(a), in exercise of the powers conferred on it by section 1 of the Seeds Act (Northern Ireland) 1965(b) and of all other powers enabling it in that behalf, after consultation with representatives of such interests as appear to it to be concerned, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 2005 and shall come into operation on 1st September 2005.

Amendment of the Seed Potatoes (Tuber and Label Fees) Regulations (Northern Ireland) 1982

2. For the Schedule to the Seed Potatoes (Tuber and Label Fees) Regulations (Northern Ireland) 1982(**c**) there shall be substituted—

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations revoke and replace the Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 2004.

The Regulations increase the fee payable for the inspection of seed potatoes from £3.75 per tonne or part of a tonne to £3.90 per tonne or part of a tonne.

The fee payable for the provision of official labels, whether or not the details have been printed thereon by the Department, has increased from £0.48 per 20 labels to £0.60 per 20 labels
