**Fire Services (Appointments and Promotion)  
(Revocation) Regulations (Northern Ireland) 2005**

*Made* - - - - *20th December 2005*

*Coming into operation* *31st December 2005*

The Department of Health, Social Services and Public Safety<sup>(1)</sup>, in exercise of the powers conferred on it by Articles 9(5) and 52(1) of the Fire Services (Northern Ireland) Order 1984<sup>(2)</sup>, and now vested in it<sup>(3)</sup>, and of every other power enabling it in that behalf, hereby makes the following Regulations:

**Citation and commencement**

1. These Regulations may be cited as the Fire Services (Appointments and Promotion) (Revocation) Regulations (Northern Ireland) 2005 and shall come into operation on 31st December 2005.

**Revocation**

2. The Regulations listed in Schedule 1 are hereby revoked.
