# LEGAL AID AND ADVICE

# Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 2005

Made - - - - 3rd March 2005

Coming into operation 11th April 2005

To be laid before Parliament

The Lord Chancellor, in exercise of the powers conferred by Articles 7(2), 22 and 27 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981(a) and now vested in him(b), hereby makes the following Regulations:

#### Citation and commencement

**1.** These Regulations may be cited as the Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 2005 and shall come into operation on 11th April 2005.

### Revocation

**2.** The Legal Advice and Assistance (Amendment) Regulations (Northern Ireland) 2004(c) are hereby revoked.

## **Amendment to Schedule 2**

**3.** For the table set out in Schedule 2 to the Legal Advice and Assistance Regulations (Northern Ireland) 1981(**d**) there shall be substituted the following table –

| Exceeding £142 but not exceeding £149 a week | £63                     |
