# The Justice (Northern Ireland) Act 2002 (Commencement No.11) Order 2006

Made - - - -

8th March 2006

The Secretary of State makes the following Order in exercise of the powers conferred by section 87 of the Justice (Northern Ireland) Act 2002(**a**).

**1.** This Order may be cited as the Justice (Northern Ireland) Act 2002 (Commencement No.11) Order 2006.

**2.** The provisions of the Justice (Northern Ireland) Act 2002 specified in the Schedule to this Order shall come into force on 3rd April 2006.

Article 2

- 1. Section 12 (role of Lord Chief Justice).
