# FIRE AND RESCUE SERVICES

The Fire and Rescue Services (2006 Order) (Commencement No.1) Order (Northern Ireland) 2006

Made - - - - 9th June 2006

Coming into operation 1st July 2006

The Department of Health, Social Services and Public Safety makes the following Order in exercise of the powers conferred by Article 1 (3) of the Fire and Rescue Services (Northern Ireland) Order 2006 (1).

#### Citation

**1.** This Order may be cited as the Fire and Rescue Services (2006 Order) (Commencement No. 1) Order (Northern Ireland) 2006.

#### Commencement

- **2.** The day appointed for the coming into operation of the following provisions of the Fire and Rescue Services (Northern Ireland) Order 2006 is 1st July 2006—
  - (a) Articles 3 to 24;
  - (b) Articles 53 to 63;
  - (c) Schedules 1 and 2;
  - (d) Schedule 3, paragraphs 1 to 18 and 20 to 23; and
  - (e) Schedule 4 in so far as it relates to—
    - (i) The Northern Ireland Assembly Disqualification Act 1975(2);
    - (ii) Articles 3 to 20 and 49A to 52 of and Schedules 1, 2, 3 and 5 to the Fire Services (Northern Ireland) Order 1984(3);
    - (iii) The Commissioner for Complaints (Northern Ireland) Order 1996(4);
