#### Citation and commencement

**1.** This Order may be cited as the Fair Employment (Specification of Public Authorities) (Amendment) Order (Northern Ireland) 2012 and shall come into operation on 31<sup>st</sup> March 2012.

**2.** For the Schedule to the Fair Employment (Specification of Public Authorities) Order (Northern Ireland) 2004(**d**) substitute the Schedule set out in the Schedule to this Order.

**3.** The Fair Employment (Specification of Public Authorities) (Amendment) Order (Northern Ireland) 2009(e) is hereby revoked.
