## ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2013

Made - - - - 10th June 2013

Coming into operation - 1st July 2013

The Department for Regional Development(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

One objection has been received and no other representations were received.

The Department has modified the draft order.

#### Citation and commencement

**1.** This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2013 and shall come into operation on 1st July 2013.

#### **Amendments**

- **2.**—(1) Schedule 1 to The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(**a**) shall be amended in accordance with paragraphs (2) to (4).
  - (2) Delete item no. 830 relating to Highfield Road, Magherafelt;
  - (3) Add the items set out in the Schedule to this Order; and
  - (4) For item no. 119 substitute the following item—
    - "The Square, Stewartstown (east side) from a point 93 metres south of its junction with West Street, for a distance of 6.5 metres."
- **3.**—(1) Schedule 1 to The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(**b**) shall be amended in accordance with paragraphs (2) and (3).
  - (2) Delete the following items—
    - (a) item no. 59 relating to Richmond Park, Ballygawley;
    - (b) item no. 491 relating to Coagh Street, Cookstown;
    - (c) item no. 503 relating to Killymoon Crescent, Cookstown;
    - (d) item no. 512 relating to Ratheen Avenue, Cookstown;
    - (e) item no. 703 relating to Killymerron Park, Dungannon;
    - (f) item no. 1276 relating to Glenview Cottages, Omagh;
    - (g) item no. 1287 relating to Meelmore Drive, Omagh;
    - (h) item no.1453 relating to Melmount Road, Sion Mills; and
    - (i) item no. 1457 relating to Eden Terrace, Strabane.
  - (3) For item no. 855 substitute the following item—

"Drumnascamph Road, Laurencetown (south-west side) - from a point 112 metres north-west of its junction with Church View Drive, for a distance of 6 metres."

Article 2 (3)

# **Unlimited Waiting**

- "941. Hillhead Road, Ballyclare (north-east side) from a point 3 metres south-east of its junction with Mill Road, for a distance of 6.6 metres in a south-easterly direction.
- 942. Hopefield Avenue, Belfast (north side) from a point 73 metres east of its junction with Cavehill Road, for a distance of 5.5 metres in an easterly direction.
- 943. Orchard Grove, Crumlin (north side) from a point 60 metres east of its junction with Orchard Road, for a distance of 6 metres in a northerly direction.
- 944. The Roddens, Larne (west side) from a point 10 metres north of its junction with St. John's Place East, for a distance of 5.5 metres in a northerly direction.
- 945. Clonboy Walk, Randalstown (west side) from a point 205 metres north of its junction with New Street, for a distance of 5 metres in a westerly direction.
- 946. Newry Street, Rathfriland (north side) from a point 104 metres west of its junction with Dromore Street, for a distance of 6 metres in a westerly direction."

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006 and The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the road specified in the Schedule, the amendment of the items specified in Articles 2(4) and 3(3) and the removal of the parking places referred to in Articles 2(2) and 3(2).
