The Road Traffic (Fixed Penalty) (Amendment No.2) Order (Northern Ireland) 2013

Made--19th July 2013Coming into operation1st September 2013

The Department of the Environment makes the following Order in exercise of the powers conferred by Article 59(1) of the Road Traffic Offenders (Northern Ireland) Order 1996(1).

# **Citation and commencement**

1. This Order may be cited as the Road Traffic (Fixed Penalty) (Amendment No.2) Order (Northern Ireland) 2013 and shall come into operation on  $1^{st}$  September 2013.

# **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order prescribes the amount of fixed penalties for certain fixed penalty offences by amending the Road Traffic (Fixed Penalty) Order (Northern Ireland) 2007 ("the Principal Order").

It amends the Principal Order to provide for new fixed penalty offences which have been specified as such by Article 2 of the Road Traffic (Fixed Penalty) (Offences) (Amendment No.2) (Order) (Northern Ireland) 2013.
