# The Road Traffic Offenders (Additional Offences) Order (Northern Ireland) 2014

Made - - - - 18th September 2014

Coming into operation - 31st October 2014

The Department of the Environment makes the following Order in exercise of the powers conferred by Article 23(3) of the Road Traffic Offenders (Northern Ireland) Order 1996(a).

#### Citation and commencement

**1.** This Order may be cited as the Road Traffic Offenders (Additional Offences) Order (Northern Ireland) 2014 and shall come into operation on 31<sup>st</sup> October 2014.

#### Amendment of the Road Traffic Offenders Order

- **2.** In Article 23(2) of the Road Traffic Offenders (Northern Ireland) Order 1996 (speeding offences etc. admissibility of certain evidence), after sub-paragraph (f)(**b**) add—
  - "(g) an offence under section 11(1) of the HGV Road User Levy Act 2013(c) (offence of using or keeping heavy goods vehicle if levy not paid)."
