The Department of the Environment makes the following Order in exercise of the powers conferred by section 59 of the Taxis Act (Northern Ireland) 2008(1).

Citation and interpretation

- 1.—(1) This Order may be cited as the Taxis (2008 Act) (Commencement No.3) Order (Northern Ireland) 2014.
 - (2) In this Order "the Act" means the Taxis Act (Northern Ireland) 2008.

Appointed day

- **2.**—(1) The day appointed for the coming into operation of the provisions of the Act specified in Part 1 of the Schedule for the purpose only of making regulations, is 24th September 2014.
- (2) The day appointed for the coming into operation of the provisions of the Act specified in Part 2 of the Schedule, is 31st October 2014.
