The Welfare Reform (Northern Ireland) Order 2015 (Commencement No. 3) Order 2016

Made - - - - 28th April 2016

The Secretary of State for Work and Pensions makes the following Order in exercise of the powers conferred by Article 2(2) of the Welfare Reform (Northern Ireland) Order 2015(a).

Those powers are exercisable by the Secretary of State by virtue of Article 4(1)(a) of that Order.

 - (b) in Schedule 9, paragraph 3.
 - (3) In Part 6, Articles 109 and 110, except in so far as those Articles relate to universal credit.
