ROAD TRAFFIC

The A90 Trunk Road (Oatyhill) (Temporary Prohibition of Specified Turns) Order 2008

Coming into force

6th March 2008 22nd March 2008

The Scottish Ministers make the following Order in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in Part 1 of the Schedule should be prohibited from making any turn specified in Part 2 of the Schedule because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they are satisfied that there is an alternative route suitable for traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A90 Trunk Road (Oatyhill) (Temporary Prohibition of Specified Turns) Order 2008, comes into force on 22nd March 2008 and ceases to have effect at midnight on 30th April 2008.

Prohibition of use of vehicles

2. Subject to Articles 3 and 4 of this Order, no person shall use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule so as to make any turn specified in Part 2 of the Schedule when such prohibition is identified as applying to any part or parts of the said length of road by means of traffic signs as prescribed by Diagram 612 of the Traffic Signs Regulations and General Directions 2002(**b**).

Direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

Exemption for emergency and works vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

SCHEDULE

PART 1

That length of the A90 Perth to Fraserburgh Trunk Road from its junction with the B974 Fettercairn Junction to its junction with the A937 Marykirk junction, a distance of 4.5km or thereby.

PART 2

- 1. All right turns from the A90 Perth to Fraserburgh Trunk Road southbound to the Oatyhill Junction on the northbound carriageway of said A90 Trunk Road.
- 2. All right turns from the Oatyhill Juction to the southbound A90 Perth to Fraserburgh Trunk Road.
- 3. All right turns from the A90 Perth to Fraserburgh Trunk Road southbound to the Mill of Thornton Junction on the northbound carriageway of said A90 Trunk Road.
- 4. All right turns from the Mill Of Thornton Junction to the southbound A90 Perth to Fraserburgh Trunk Road.
- 5. All right turns from the A90 Perth to Fraserburgh Trunk Road southbound to the Mill of Barnes Junction on the northbound carriageway of said A90 Trunk Road.
- 6. All right turns from Mill of Barnes Junction to the southbound A90 Perth to Fraserburgh Trunk Road.
- 7. All right turns from the A90 Perth to Fraserburgh Trunk Road northbound carriageway to the Dunthilll Junction on the southbound carriageway of said A90 Trunk Road.
- 8. All right turns from the Dunthill Junction to the northbound A90 Perth to Fraserburgh Trunk Road.
- 9. All right turns from the A90 Perth to Fraserburgh Trunk Road southbound to the Drumnagair Junction on the northbound carriageway of said A90 Trunk Road.
- 10. All right turns from the Drunagair Junction to the southbound A90 Perth to Fraserburgh Trunk Road.
- 11. All right turns from the A90 Perth to Fraserburgh Trunk Road northbound carriageway to the Dubton Junction on the southbound carriageway of said A90 Trunk Road.
- 12. All right turns from the Dubton Junction to the northbound A90 Perth to Fraserburgh Trunk Road.
- 13. All right turns from the A90 Perth to Fraserburgh Trunk Road southbound to Dubton Cottage on the northbound carriageway of said A90 Trunk Road.
- 14. All right turns from Dubton Cottage to the southbound A90 Perth to Fraserburgh Trunk Road.
